Numbers and variables

On completion of this chapter you will be able to

- identify the different kinds of numbers
- draw a number line
- round numbers off
- explain what a variable is
- write down an elementary expression or equation by using variables

In this first chapter, we address some of the basic terminology and notations you will need in this course.

1.1 Numbers

We use numbers to describe and measure quantities. A number is an abstract entity, an idea we use to express a quantity. Various symbols can be used to represent the same number, for instance, “4”, “3+1”, “four” and “IV”. Let us tell you about the different kinds of numbers we are going to use in this course.

The most fundamental system of numbers is the ***natural numbers*** we use to count things, starting with the number one. We can write it as a set, which is a grouping or collection of similar things. Curly brackets are used to indicate sets.

The set of natural numbers is

$$\{1; 2; 3; 4; 5; \dots\}.$$

(The three dots $\dots$ at the end indicate that the set continues indefinitely).

The elements of the set are 1, 2, 3, 4, 5 and so on.

Natural numbers can be used for counting (“there are two (2) books on the table”) and for ordering (arranging in sequence) (“this is the fourth (4th) largest apple”).

Natural numbers are also called **positive integers**.

To indicate the absence of certain things (such as when your team fails to score), the number 0 was added. This gives us the set of **counting numbers**:

$$\{0; 1; 2; 3; 4; 5; \dots\}.$$

Counting numbers are also called **non-negative integers**.

Situations may arise where positive numbers alone are not sufficient. For example, we can subtract a larger number from a smaller one. The negative numbers are usually represented by a minus sign in front of the number concerned. The set of **negative integers** is

$$\{\dots; -5; -4; -3; -2; -1\}.$$

When working with negative numbers it is important to distinguish between the sign of an operation (addition and subtraction) and the sign of a number (positive or negative). The $\boxed{+/-}$, $\boxed{(-)}$ or $\boxed{\text{NEG}}$ key on different calculators is used to enter a negative number or to change its sign, while the $\boxed{-}$ is used for subtraction.

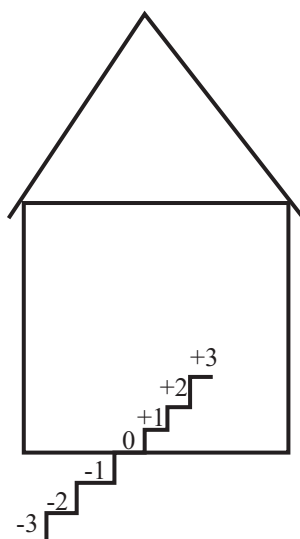


Figure 1.1: Steps inside a building.

Negative numbers are used to describe values below zero, such as temperature and debt. Negative numbers provide a convenient way of indicating opposite direction with a minimum of words, for example, steps inside a building (see figure 1.1).

The following example illustrates the positive and negative integers. Let us look at something we are all familiar with – steps inside a building.

We indicate ground level, where there is no step, as 0 (zero). The steps above ground level are numbered +1, +2, +3, and so on. The plus sign does not indicate the operation of addition; it is a sign of direction, in this case meaning **above** ground level. In the basement the steps are numbered –1, –2, –3, and so on, indicating **below** ground level (the opposite direction).

Combining the negative integers and the non-negative integers (or zero plus the positive integers) yields the set of integers:

$$\{\dots - 3; -2; -1; 0; 1; 2; 3; \dots\}.$$

One property of this set is that for every positive integer, there is a corresponding negative integer such that their sum is zero. In other words, if we add -3 and $+3$, the answer is zero (0).

The number line is one way to represent a set of numbers graphically. To illustrate the construction of a number line, we place the elements of the integer set in one-on-one correspondence with points on a line. Draw a straight horizontal line and mark a point near the middle as 0 (zero) on it. We call this point the origin. Since integers are equally spaced, we select points around 0 (zero) with equal distances between them. This distance between any two points is called the scale, a familiar example being the scale on a thermometer. Certain conventions are usually followed when using number lines; positive integers are associated with points to the right of 0 (zero) and negative integers are associated with points to the left of 0 (zero). See figure below.

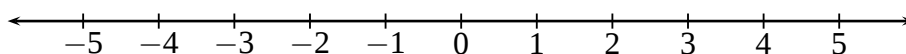


Figure 1.2: The number line.

The arrows at the end of the number line mean that the numbers continue infinitely.

Thus far we have not mentioned any numbers other than integers. The number line also gives us a picture of the relationship between integers and other numbers. The integers are marked on the line, but each point in between the integer markings also represents a number. Examples are the points representing the numbers $\frac{1}{2}$ (located halfway between 0 and 1) and -2.5 (located halfway between -2 and -3) on the line. There are in fact an infinite num-

ber of points between two integer markings. All these points on the number line (that is the solid line) represent the set of **real numbers**. Note that integers are real numbers. They are special real numbers.

1.2 Rounding of numbers

Rounding is the process of reducing the number of digits in a number while trying to keep the value similar. Rounded numbers are less accurate, but easier to use.

In this course we will be using the common method to do rounding. The rule for applying this method is as follows:

- Decide which is the last digit that you will keep.
- Increase this digit by one if the **next** digit to the right is “5” or more, and discard the rest.
- Leave this digit the same if the **next** digit to the right is less than “5”, and discard the rest.

Example 1.1

1. Round 4,36923 to three decimal digits.

You want to keep three digits, so the “9” will be the last digit. The next digit to the right is “2”, which is less than five. Drop the “23” part to get 4,369.

2. Round 4,36923 to two decimal digits.

You want to keep two digits, so the “6” will be the last digit. The next digit is “9”, which is more than five. Add one to the “6” and drop the “923” part to get 4,37.

3. Round 4,36923 to an integer.

You want to keep only integers, so the “4” is the last digit. The next digit is “3”, which is less than five. Drop the “36923” part to get 4.

Before rounding a number, you need to think carefully. Keep the following in mind:

- If a interest rate is 16,25%, then you should not round it to 16%. There is a big difference if you calculate interest on a loan using a 16% interest rate instead of a 16,25% interest rate!
- However, what does it mean if you calculate the price of an article as R27,5394? When working with money, it makes more sense if we round to two decimal digits.
- Do not round to integers unless it is obvious, or asked for.
- Do not round in the middle of a problem. Use all the digits, and **only round your final answer.**

1.3 Variables

A variable is a symbol for a number we do not know. It can be seen as a place holder for an unknown number. Variables are useful because they allow us to write down unknown values in expressions¹ and equations². In the expression $x + 7$, the symbol x indicates a variable because we do not know its value. We call an expression with variables in it an algebraic expression. Algebra is basically a shorthand system.

For example, an expression for the area of a rectangular plot of land of unknown size can be constructed. Call the length of the rectangle ℓ and its width w . Then you can say that the area of the rectangle is $\ell \times w$. This will be true for any value of ℓ and w . Once the values of ℓ and w are specified we can calculate the value of the expression. For example, if the length is 4 metres and the width is 3 metres, we substitute ℓ with 4 and w with 3 to get the area of the plot: $\ell \times w = 4 \times 3 = 12$. The area is 12 square metres.

This is the great value of using variables — we can write down expressions which are completely general. To find the answer in a particular case, all we need to do is to substitute our particular values, as explained above.

Multiplication of numbers by variables can be represented in more than one way, for example:

- with a multiplication sign: $4 \times a$
- with a dot: $4 \cdot a$
- with brackets: $4(a)$
- or straight: $4a$

Example 1.2

Make use of variables and write the following sentences as algebraic expressions or equations:

- (a) Add 7 to an unknown value.

$x + 7$ (or $a + 7$ or $p + 7$, and so on)

- (b) Subtract a from b .

$b - a$

¹An expression is a combination of numbers, operators, brackets and variables. Two examples of expressions are $3x - 6$ and 2×5 .

²An equation is a statement that says that what is on the left of the equal sign (“=”) is equal to what is on the right of it. Two examples of equations are $7x - 4 = 1$ and $2 + 4 = 6$.

(c) The sum of x and y is equal to z .

$$x + y = z$$

To summarise

- We can represent any unknown value by a symbol, and we call this symbol a variable.
- A variable can represent or assume any numerical value.
- The symbols most often used to represent variables are lower case letters of the alphabet, such as a , b , x and y .
- Acronyms are used as variables, for example, PV for present value.
- Choose a symbol that is short and that makes sense.

(Rosser 2003)

Example 1.3

A biscuit manufacturer uses the following ingredients for each packet of biscuits produced: 0,2 kg of flour, 0,05 kg of sugar and 0,1 kg of butter.

One way we could specify the total amount of flour used, is: 0,2 kg times the number of packets of biscuits produced. However, it is easier and simpler if we let the letter q (for quantity) represent the number of packets of biscuits produced.

We can then say that:

- the total amount of flour required is $0,2q$ kilograms
- the total amount of sugar required is $0,05q$ kilograms
- the total amount of butter required is $0,1q$ kilograms

Basic operations on numbers and variables

On completion of this chapter you will be able to

- use basic powers and roots in calculations
- perform multiple basic operations in the correct order

2.1 Basic operations on numbers

You are already familiar with the basic rules for working with numbers. We are going to review them and let you practise them on your calculator.

If you have not yet taken your SHARP EL-738FB calculator out of its box, now is the time to do so! In Tutorial Letter 101 you will find notes on how to use the calculator. Work through the first four paragraphs up to “*Financial calculator mode*”.

The four basic operations are: addition, subtraction, multiplication and division.

2.1.1 Addition and subtraction

When numbers are *added*, the answer is called the *sum* or the *total* of the numbers.

The sum of two real numbers is unique, that is, it does not matter which number is placed first and which second — the result is the same. For example

$$6 + 2 = 2 + 6 \text{ (both are equal to 8)}$$

The sum of three numbers also does not depend on which two are added first; the result is unique. For example

$$2 + (5 + 4) = (2 + 5) + 4 \text{ (both are equal to 11)}$$

Try these two examples on your calculator and see if you come to the same conclusion.

When numbers are *subtracted*, the result is called the *difference* of the two numbers.

Let us investigate if the difference of two real numbers is unique. Again, take the two numbers 6 and 2:

$$6 - 2 = 4$$

and

$$2 - 6 = -4$$

We see that $6 - 2 \neq 2 - 6$. (The sign $\neq$ is read as “does not equal”.) Changing the order when subtracting leads to the negative of the initial result, therefore the difference is not unique. This result means that we need to make very sure that the order is correct before we do any subtraction.

(a) $7 + (3 + 2) = (7 + 3) + 2$

(b) $6 + (-5 + 3) = (6 + -5) + 3$

(a) Subtract 5 from 8 to get a difference of 3.

(b) Subtract -5 from -8 to get a difference of -3 .

Consider the following problem (Rosser 2003) involving multiple operations of addition and subtraction.

Example 2.1

1. A train leaves its terminus with 19 passengers on board. At the first station 4 passengers get off and 9 get on. At the second station 15 get off and 1 gets on. How many passengers remain on the train?

Most of you would probably answer this by saying $19 - 4 = 15$ and $15 + 9 = 24$. Then $24 - 15 = 9$ and $9 + 1 = 10$ passengers remaining, which is the correct answer. If you were faced with the problem

$$19 - 4 + 9 - 15 + 1 = ?$$

you should simplify it in the same way, that is, **from the left to the right**. That means

$$19 - 4 + 9 - 15 + 1 = 10$$

When an expression contains only the two operations, of **addition and subtraction**, without any brackets, the rule is to perform them **from left to right**.

2.1.2 Multiplication and division

Multiplication

When two numbers are *multiplied* the answer is called the *product* of the two numbers. The numbers we multiply are called *factors*.

Again, the product of two real numbers is unique, that is, it does not matter which number is placed first and which second — the result is the same. For example

$$6 \times 2 = 2 \times 6 \text{ (both are equal to 12)}$$

The product of three numbers also does not depend on which two are multiplied first; the result is unique. For example

$$2 \times (5 \times 4) = (2 \times 5) \times 4 \text{ (both are equal to 40)}$$

Try these two examples on your calculator and see if you come to the same conclusion.

When multiplying with plus and minus signs, the rule is as follows:

- If we multiply two numbers with the same signs, the answer is a positive number, that is

$$+ \times + = +$$

and

$$- \times - = +$$

- If we multiply two numbers with different signs, the answer is a negative number, that is

$$+ \times - = -$$

and

$$- \times + = -$$

Note that we usually do not write the positive sign, +. A number without a sign indicates a positive number.

Example 2.2

1. $-2 \times 3 = -6$

2. $-2 \times -3 = +6 = 6$

Division

When one number is *divided* by another number, the answer is called the *quotient*.

The specific terminology we use in *division* is

$$\text{dividend} \div \text{divisor} = \text{quotient}.$$

If we look at $6 \div 2 = 3$, 6 is the *dividend*, 2 the *divisor* and 3 the *quotient*.

Let us investigate if the quotient of two real numbers is also unique. Again, take the two numbers 6 and 2:

$$6 \div 2 = 3$$

and

$$2 \div 6 = \frac{1}{3}$$

We see that $6 \div 2 \neq 2 \div 6$. Changing the order when dividing leads to the inverse of the initial result (that is, $\frac{1}{3}$ instead of 3), and therefore the quotient is not unique.

When dividing with plus and minus signs, the rule is as follows:

- If we divide two numbers with the same signs, the answer is a positive number, that is

$$+ \div + = +$$

and

$$- \div - = +$$

- If we divide two number with different signs, the answer is a negative number, that is

$$+ \div - = -$$

and

$$- \div + = -$$

Example 2.3

$$1. \ 12 \div -3 = -4$$

$$2. \ -12 \div -3 = +4 = 4$$

When adding long rows of numbers, it does not matter which numbers we add first and which last. A similar remark applies to multiplication, but when we come to subtraction and division, we must be very careful, as the following examples show:

$$10 - (5 - 2) \neq (10 - 5) - 2$$

and

$$(8 \div 4) \div 2 \neq 8 \div (4 \div 2)$$

This means that an expression like $8 \div 4 \div 2$ is highly ambiguous because the result depends on the order in which we perform the division. The SHARP EL-738FB interprets $8 \div 4 \div 2$ as $(8 \div 4) \div 2$, which is equal to $(2) \div 2 = 1$, since it works from left to right. When an expression contains only the two operations of **multiplication** and **division**, without any brackets, the rule is to perform the operation from left to right. Therefore

$$8 \div 2 \times 4 = 16.$$

You can enforce a specific order by using brackets, for example

$$8 \div (2 \times 4) = 8 \div 8 = 1.$$

We can conclude that, although we can change the order of the numbers for addition and multiplication, we cannot do it for subtraction and division.

Consider the following problem (Rosser 2003) involving multiple operations of multiplication and addition.

Example 2.4

1. A restaurant catering for a large party sits six people to a table. Each table requires two dishes of vegetables. How many dishes of vegetables are required for a party of 60?

Most people would answer this by saying $60 \div 6 = 10$ tables and $10 \times 2 = 20$ dishes, which is correct.

If this problem is set as $60 \div 6 \times 2 = ?$ then the left to right rule must be used. If you did not use this rule, you might get

$$60 \div 6 \times 2 = 60 \div 12 = 5$$

which is *incorrect*.

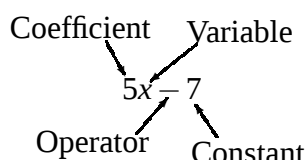

2.2 Basic operations on variables

Before we proceed with the basic operations on variables, we need to discuss some more terminology.

Let us look at the following expression:



You already know that a **variable** is a symbol for an unknown number. In this expression the variable is x . An **operator** is a symbol representing an operation, in this case subtraction. A **constant** always has the same value; it is a fixed number, in this case 7. A **coefficient** is the number in front of a variable. In this case the coefficient of x is 5.

If we look at the expression $3x + 7y + 2$, we see that the constant is 2, the coefficient of y is 7 and the coefficient of x is 3.

There are some basic rules when working with variables. In language we put letters or sounds together to form words, and words put together make sentences. If we think of an expression as a mathematical sentence, the words could be seen as *terms* made up from numbers and variables. For example, in the expression

$$5x + 4ab - 6y$$

there are three terms, namely, $5x$, $4ab$ and $-6y$. The numbers and variables we multiply together to produce a term are called *factors*. In the term $4ab$, the following are all factors of $4ab$:

$$4, a, b, 4a, 4b \text{ and } ab$$

Here are two more general notes concerning notation:

- Note that when we have more than one variable in a factor, we arrange the variables alphabetically. For example, we write $4ab$, rather than $4ba$.
- If the coefficient is 1, we usually do not write it. For example, $1y$ is written as y , or $1xy$ is written as xy , and $-1x$ is written as $-x$.

A special notation is also used when a factor is repeated in a term, for example, $4 \times 4 \times 4$. We first write down the factor that is repeated, in this case 4. Then we count how many times the factor is repeated, 3, and write it down to the right of and higher than the factor (superscript) to get: 4^3 . We call the “3” the exponent of the number 4, but we say “four to the power three” or “the third power of four”. Similarly, $5 \times 5 = 5^2$ and we say “five to the power two” or “the second power of five”.

The repeated factor can also be a variable, so that $x \times x \times x \times x \times x = x^5$ and we say “ x to the power five” or “the fifth power of x ”.

We will discuss powers and exponents later again.

2.2.1 Addition and subtraction

The expression $4xy + 2x + 5y - 3z$ has four terms, namely $4xy$; $2x$; $5y$ and $-3z$. We can say that terms are separated by $+$ and $-$ signs. (Factors are separated by $\times$ signs).

When adding or subtracting, we only add or subtract *like terms*. Terms are alike when they have exactly the same combination of letter variables. For example, we can add $4a$, $8a$ and $3a$, but we cannot add $4a$, $2b$ and $8ab$.

We cannot simplify the expression $2x + 5y - 3z$ because $2x$, $5y$ and $-3z$ are not like terms. We can, however, simplify the expression $2x + 5x - 3z$ by adding the two like terms to get $7x - 3z$.

When adding or subtracting like terms we add or subtract the coefficients and keep the letter variable part as it is. For example, when we add $6a$ to $3a$, we add the 6 to the 3 to get 9 and keep the a to get the sum of $9a$:

$$\begin{array}{l} 6 + 3 = 9 \\ \quad \swarrow \searrow \\ \quad \text{6a + 3a = 9a} \end{array}$$

Example 2.5

Simplify the following expressions:

(a) $x + x$

$2x$ (Remember that there is actually a coefficient of 1 in front of x .)

(b) $-7a - 3a$

$-10a$

(c) $3x^2 + 4x$

$3x^2 + 4x$ (The two terms are not like terms.)

Note that:

- xy and yx are like terms when ordered (and should be ordered) and can thus be added. That means

$$xy + yx = xy + xy = 2xy.$$

- x^2y and xy^2 are not like terms. (The exponents must also be exactly the same.) That means

$$x^2y + xy^2 = x^2y + xy^2,$$

which is the simplest form of the expression.

- x^2y^3 and x^3y^2 are not like terms, therefore

$$x^2y^3 + x^3y^2 = x^2y^3 + x^3y^2$$

in its simplest form.

2.2.2 Multiplication and division

We are familiar with the multiplication of two numbers, but not necessarily with the multiplication of two variables or the multiplication of a number and a variable.

In section 1.3 we saw that $6c$ means that 6 is multiplied with c . In the term $6c$ we say that both 6 and c are factors of $6c$.

When we want to multiply $6c$ with $8a$, we first multiply the numbers (the coefficients): $6 \times 8 = 48$. (Always keep the sign rule in mind.) Then multiply

the variables: $c \times a = ca = ac$. (Always arrange the variables in the product alphabetically.) Thus

$$6c \times 8a = 48ac.$$

Now what about $6c \times 6c$? We follow the same method as above and first multiply the coefficients: $6 \times 6 = 36$. Then multiply the variables and remember the special notation for repeated factors: $c \times c = c^2$. Thus

$$6c \times 6c = 36c^2.$$

Let us look at a few more examples.

Example 2.6

1. Simplify $6a \times -2b$

$$6 \times -2 = -12$$

$$a \times b = ab$$

Thus

$$6a \times -2b = -12ab$$

2. Simplify $-5x \times -4y$

$$-5x \times -4y = 20xy$$

3. Simplify $-3xy \times 4xy$

$$-3xy \times 4xy = -12x^2y^2$$

Now it is your turn to do a few multiplications!

Let us look at examples for division of terms containing variables and numbers.

Example 2.7

Simplify:

$$(a) \frac{-6a}{2a}$$

We divide the numbers $-6 \div 2 = -3$.

The a 's cancel out, that is, $a \div a = 1$.

Thus

$$\frac{-6a}{2a} = \frac{-6 \times 1}{2 \times 1} = -\frac{6}{2} = -3.$$

$$(b) \frac{20xy}{-5x}$$

Divide the coefficients first, keeping the sign rule in mind:

$$20 \div -5 = -4.$$

The x 's cancel out, leaving only y .

Thus

$$\frac{20xy}{-5x} = \frac{20 \times x \times y}{-5 \times x} = \frac{20 \times 1 \times y}{-5 \times 1} = -4y.$$

$$(c) \frac{-5x}{20xy}$$

We get

$$\begin{aligned} \frac{-5x}{20xy} &= \frac{-5x}{4 \cdot 5xy} \\ &= -\frac{1}{4y}. \end{aligned}$$

Note: The lines in

$$\frac{-5x}{4 \cdot 5xy}$$

over the numbers and variables mean that we cancel out factors.

$$(d) \frac{18x^2y}{3xy^2}$$

We get

$$\begin{aligned} \frac{18x^2y}{3xy^2} &= \frac{3 \cdot 6 \cdot x \cdot x \cdot y}{3 \cdot x \cdot y \cdot y} \\ &= \frac{6x}{y}. \end{aligned}$$

When you multiply or divide expressions, always use the following order:

- Establish the sign of the answer by using the applicable sign rule.
- Multiply or divide the numbers (coefficients).
- Multiply or divide the variables.

It is time for some more exercises.

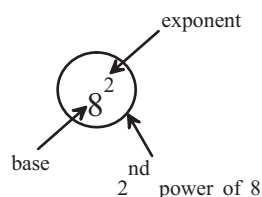
2.3 Powers

In section 2.2 you were briefly introduced to powers. Here we revisit the special notation and introduce you to the rules (laws) of exponents.

A power consists of a base and an exponent for example, 8^2 is a power, the second power of 8.

2.3.1 Exponents

In the expression 8^2 the base is 8, the exponent is 2, and the power is the whole expression, 8^2 .



The exponent tells you how many times the base is multiplied with itself. In this example: $8^2 = 8 \cdot 8 = 64$. In words we would say “eight to the power two” or “eight squared”. We can also say “the second power of eight”.

In general we say that if a number a is multiplied by itself n times, it is written as a^n .

$$\underbrace{a \times a \times a \times \cdots \times a}_{n \text{ times}} = a^n$$

In this general case, a is the base and n the exponent.

Note that $a^1 = a$, for example $4^1 = 4$.

Remember that the value of any base **to the power one** is always just the base. For example,

$$5^1 = 5 \text{ and } x^1 = x.$$

What about a number or variable **to the power zero**?

By definition, any number or variable to the power zero is one, so that

$$10^0 = 1, 4^0 = 1 \text{ and } a^0 = 1.$$

See the notes in tutorial letter 101, on using your calculator, to obtain the value of an exponential expression by using the power key y^x .

Now what about **negative exponents**? If $10^2 = 100$, what does 10^{-2} mean?

By definition,

$$10^{-2} = \frac{1}{10^2} = \frac{1}{100}$$

Note that 10^{-2} is *not* a negative number.

To deal with this, we use the concept of the inverse (or reciprocal) of a number. The inverse or reciprocal of a number is the result we obtain when we divide 1 with the number. For example, the inverse of 10 is $\frac{1}{10}$. Now we can write $\frac{1}{10}$ as 10^{-1} , or 10^{-1} at $\frac{1}{10}$.

Thus, for any base with an exponent, the *inverse* is found by using the same base, but changing the *sign* of the exponent.

Therefore, by definition

$$a^{-1} = \frac{1}{a}$$

and in general

$$a^{-n} = \frac{1}{a^n}.$$

We can write: $10^{-1} = \frac{1}{10}$; $5^{-2} = \frac{1}{5^2}$; $x^{-5} = \frac{1}{x^5}$ and so on.

Vice versa, we can write $\frac{1}{3}$ as 3^{-1} , $\frac{1}{x^2}$ as x^{-2} , etc.

The key on the calculator that we can use to calculate the inverse is

$\boxed{1/x}$. (On other calculators it may be $\boxed{x^{-1}}$.) See the notes on using your calculator, in tutorial letter 101 on how to obtain the value of an exponential expression with a negative exponent.

2.3.2 Laws of exponents

In this section we will deduce the laws of exponents by using examples.

1.

$$\begin{aligned} a^2 \times a^3 &= a \times a \quad \times \quad a \times a \times a \\ &= a \times a \times a \times a \times a \\ &= a^5 \end{aligned}$$

Thus, we can deduce from the above that when we multiply two or more terms with *similar bases*, we add the exponents.

$$a^m \times a^n = a^{m+n}$$

2.

$$\begin{aligned}\frac{a^4}{a^2} &= \frac{a \times a \times a \times a}{a \times a} \\ &= a^2\end{aligned}$$

When we divide two terms with *similar bases*, we subtract the exponents from each other.

$$\frac{a^m}{a^n} = a^{m-n}$$

3.

$$\begin{aligned}(a^2)^3 &= (a^2) \times (a^2) \times (a^2) \\ &= a \times a \quad \times \quad a \times a \quad \times \quad a \times a \\ &= a^6\end{aligned}$$

When we raise a power (base with exponent) to a power, we multiply the exponents with each other.

$$(a^m)^n = a^{m \times n} = a^{mn}$$

4.

$$\begin{aligned}(ab)^3 &= (ab) \times (ab) \times (ab) \\ &= a \times b \times a \times b \times a \times b \\ &= a \times a \times a \times b \times b \times b \\ &= a^3 b^3\end{aligned}$$

When we raise a product to a power, it is equal to the product of each factor raised to the same power.

$$(ab)^m = a^m b^m$$

2.4 Roots

In the previous paragraph, when we multiplied 8 with itself, we wrote $8 \times 8 = 8^2$ and in words we said “eight squared”. More examples of squares are

4 squared $= 4^2 = 4 \times 4 = 16$

5 squared $= 5^2 = 5 \times 5 = 25$

6 squared $= 6^2 = 6 \times 6 = 36$

A *square root* goes in the other direction:

3 squared is 9, so the square root of 9 is 3.

The square root of a number is the value that, when multiplied by itself, gives the number.

We not only have square roots, but also third roots, fourth roots and so on.

The symbol we use for roots in general is $\sqrt[n]{}$. Examples of specific roots are:

square root: $\sqrt{}$

third root: $\sqrt[3]{}$

fourth root: $\sqrt[4]{}$

By convention we do not write the small 2 in front of the symbol for the square root, but only $\sqrt{}$. If you come across a root symbol without a small number in front, you know that it is a *square* root. Most calculators have a square root key $\sqrt{}$. (See the notes on using your calculator, in tutorial letter 101)

Another example:

$$7^2 = 49 \text{ and } \sqrt{49} = 7$$

(We say “the square root of 49 is 7”.)

By using the SHARP EL738FB calculator:

Example 2.8

1.

$$\sqrt{49} = ?$$

Calculator steps:

$$\boxed{2\text{ndF}} \boxed{\sqrt{}} 49 \boxed{=}$$

The answer is 7.

2.

$$\sqrt[3]{216} = ?$$

Calculator steps:

$$3 \boxed{2\text{ndF}} \boxed{\sqrt[3]{}} 216 \boxed{=}$$

The answer is 6.

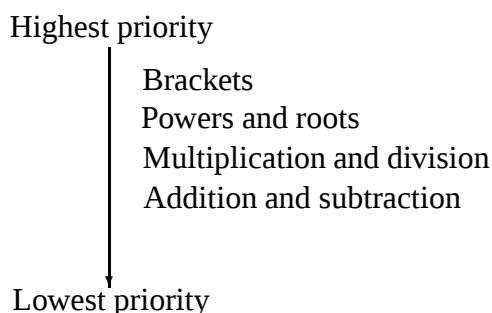

2.5 Order of operations

When you see something like $3 + 2 \times 5$, which part should you calculate first? Your instinct might be to start the operations from the left and go to the right, as if you were reading. That might seem natural, but you will get a wrong answer in the case of $3 + 2 \times 5$. In problems involving more than one operation (such as addition and multiplication in this case) certain rules, called *priority rules*, must be followed.

It is essential that when we see an expression, we all understand it to mean the same thing; then we will all obtain the same result. We all have to agree to perform the operations in a specific order. The commonly accepted convention or rule for operations is:



Example 2.9

Calculate the value of the expression $2 \times 3 - 4 \times 5 + 6 \div 3$.

There are no brackets, powers or roots in the expression, so we start with the multiplication and division:

$$\underbrace{2 \times 3}_6 - \underbrace{4 \times 5}_{20} + \underbrace{6 \div 3}_2$$

Now we have $6 - 20 + 2$ which is equal to $-14 + 2 = -12$.

Therefore $2 \times 3 - 4 \times 5 + 6 \div 3 = -12$.

Calculate the value of the following two expressions. In each case state the order in which the operations are performed. When priorities are equal, operate from left to right.

(a) $4 \times 3 \div 2 + 5 \times 6 - 20 \div 4 \times 2$

What if you want to deviate from these predetermined priorities? Say for instance, in the example

$$2 \times 3 + 4 \times 5,$$

we actually need to add $3 + 4$ first and then multiply the sum by 2 and 5. How can we achieve this? The answer is: we use brackets. We write

$$2 \times (3 + 4) \times 5.$$

This expression indicates that we must first calculate the expression in brackets, $(3 + 4)$, and then do the other operations:

$$2 \times \underbrace{(3 + 4)}_7 \times 5$$

Now we have $2 \times 7 \times 5 = 70$ as the value of the expression.

We call “(” the left or open bracket and “)” the right or closed bracket. The number of open brackets and closed brackets must always be the same, otherwise the expression is not uniquely specified.

We now know that brackets within an expression have the highest priority and must always be calculated first. But what about brackets within brackets? Always work from the innermost bracket outwards. Note that within a set of brackets, the usual priority rules apply. An expression underneath a root sign, should be seen as if in brackets.

Example 2.10

Calculate the value of the following expression:

$$\sqrt{3 \times \sqrt{4^2 + 3^2} + (4 + 3)^2}$$

Step-by-step, we do the calculation as follows:

Step	Reduced expression
1	$\sqrt{(3 \times \sqrt{(4^2 + 3^2)} + (4 + 3)^2)}$
2	$\sqrt{(3 \times \sqrt{(16 + 9)} + (7)^2)}$
3	$\sqrt{(3 \times \sqrt{25} + 7^2)}$
4	$\sqrt{(3 \times 5 + 49)}$
5	$\sqrt{(15 + 49)}$
6	$\sqrt{64}$
7	8

Let us look at the order of operations in the following example:

- **Do the brackets first**

$$\begin{aligned} 3 \times (5 + 6) &= 3 \times 11 = \mathbf{33} \quad (\text{right}) \\ 3 \times (5 + 6) &= 15 + 6 = 21 \quad (\text{wrong}) \end{aligned}$$

- **Powers and roots before multiplication, division, addition and subtraction**

$$\begin{aligned} 5 \times 2^2 &= 5 \times 4 = \mathbf{20} \quad (\text{right}) \\ 5 \times 2^2 &= 10^2 = 100 \quad (\text{wrong}) \end{aligned}$$

- **Multiplication or division before addition and subtraction**

$$\begin{aligned} 2 + 5 \times 3 &= 2 + 15 = \mathbf{17} \quad (\text{right}) \\ 2 + 5 \times 3 &= 7 \times 3 = 21 \quad (\text{wrong}) \end{aligned}$$

- Otherwise just go left to right

$$30 \div 5 \times 3 = 6 \times 3 = 18 \quad (\text{right})$$

$$30 \div 5 \times 3 = 30 \div 15 = 2 \quad (\text{wrong})$$

More operations on numbers

On completion of this chapter you should be able to

- list all the factors of a certain number

3.1 Factors

3.1.1 What is a factor?

All integers, have factors. Some numbers have more factors than others.

A factor of a number is a number by which it can be divided without leaving a remainder.

1 and the number itself, are always factors of a certain number. Let us look at the following example.

Example 3.1

1. The factors of 6.

If 6 is divided with 1 the answer is 6.

If 6 is divided with 2 the answer is 3.

If 6 is divided with 3 the answer is 2.

If 6 is divided by 6 the answer is 1.

Therefore, the factors of 6 are: 1, 2, 3 and 6, because all these numbers divide exactly into 6, that is without a remainder.

If we write $6 = 2 \times 3$, we have factorised 6.

2. The factors of 8.

If 8 is divided by 1, the answer is 8.

If 8 is divided by 2, the answer is 4.

If 8 is divided by 4, the answer is 2.

If 8 is divided by 8, the answer is 1.

Therefore, the factors of 8 are 1, 2, 4 and 8.

If we write $8 = 2 \times 4$, we have factorised it.

If we write $8 = 2 \times 2 \times 2$, we have factorised 8 in prime factors.

Note: Prime numbers all have only two factors, namely 1 and the number itself, e.g. 7 has no other factors than 1 and 7. Another such a number is 11. We can try to list the prime numbers:

1, 2, 3, 5, 7, 11, 13, 17, 19, 23, etc.



3.1.2 The lowest common multiple (LCM)

Firstly, we have to know what a multiple of a whole number is. A multiple of a number is found by taking the *product* of that number and any counting number. For example, to find the multiples of 3, multiply 3 by 1, or 3 by 2, or 3 by 3, and so on. The multiples of 3 are thus 3, 6, 9, 12, 15, etc. To find the multiples of 5 multiply 5 by 1, 5 by 2, 5 by 3, and so on. The multiples of 5 are thus 5, 10, 15, 20, etc.

If we have two numbers and wish to determine the lowest common multiple (LCM) of the two numbers, we want the smallest number which is a multiple of both these numbers.

Example 3.2

1. Determine the LCM of 6 and 8.

Method 1:

The multiples of 6 are:

6; 12; 18; **24**;

The multiples of 8 are:

8; 16; **24**;

It is clear from the above, that the **lowest** common multiple of 6 and 8 is 24.

Method 2:

First we factorise 6 and 8 in **prime** factors:

$$6 = 2 \times 3$$

$$8 = 2 \times 2 \times 2$$

Now to determine the LCM, we write down the prime factors of the first number (6), in factorised form, that is

$$2 \times 3$$

Now see which prime factors of the second number have NOT been written down yet. We see that the prime factors of the second number (that is the 8) are $2 \times 2 \times 2$. Only one 2 has been written down, so we must add another two 2s, as factors of the LCM.

$$6 = 2 \times 3$$

$$8 = 2 \times 2 \times 2$$

$$\begin{aligned} \text{Therefore, LCM} &= 2 \times 3 \times 2 \times 2 \\ &= 24 \end{aligned}$$

2. Determine the LCM of

(a) 30 and 45

Method 1:

$$30 = 2 \times 15 = 2 \times 3 \times 5$$

$$45 = 5 \times 9 = 5 \times 3 \times 3$$

$$\begin{aligned} \text{Therefore, LCM} &= 2 \times 3 \times 5 \times 3 \\ &= 90 \end{aligned}$$

Method 2:

The multiples of 30 are 30; 60; (90); 120; 150; ... etc.

The multiples of 45 are 45; (90); ... etc.

Therefore, the LCM of 30 and 45 is 90.

(b) 3 and 8 and 24

Method 1:

$$\begin{aligned}
 3 &= 3 \\
 8 &= 2 \times 2 \times 2 \\
 24 &= 3 \times 2 \times 2 \times 2 \\
 \text{LCM} &= 3 \times 2 \times 2 \times 2 \\
 &= 24
 \end{aligned}$$

Method 2:

The multiples of 3 are 3; 6; 9; 12; 15; 18; 21; (24); 27; ... etc.

The multiples of 8 are 8; 16; (24); 32; 40; ... etc.

The multiples of 24 are (24); 48; ... etc.

Therefore, the LCM of 3, 8 and 24 is 24.

3.2 Fractions

3.2.1 What is a Fraction?

A fraction is a numerical quantity that is not a whole number.

A fraction consists of a numerator and denominator:

$$\frac{3}{4} : \frac{\text{numerator}}{\text{denominator}}$$

The numerator tells us how many parts of the denominator there are. Thus there are 3 quarters in a $\frac{3}{4}$.

3.2.2 Types of fractions

- Proper fractions:

A proper fraction is a fraction with a numerator that is smaller than the denominator.

$$\frac{3}{7}; \frac{2}{5}; \frac{13}{17}; \text{ etc}$$

- Improper fractions

An improper fraction is a fraction with a numerator that is larger (bigger) than the denominator:

$$\frac{4}{3}; \frac{7}{5}; \frac{13}{12}; \text{ etc}$$

- Mixed fractions

Consider the improper fraction $\frac{3}{2}$, meaning “three halves”. We know that three halves are equal to $1\frac{1}{2}$, which we call a mixed fraction. How did we get the $1\frac{1}{2}$? As follows:

We divide the numerator by the denominator. This gives us the integer, with the remainder being the numerator over the existing denominator.

Example 3.3

1. Change the following improper fractions into mixed fractions:

(a) $\frac{7}{5}$

We divide 5 into 7 giving us 1, with a remainder of 2.

$$\frac{7}{5} = 1\frac{2}{5}$$

(b) $\frac{17}{6}$

We divide 6 into 17 giving us 2 with a remainder of
 $(17 - 12) = 5$.

$$\frac{17}{6} = 2\frac{5}{6}$$

Can one change mixed fractions into improper fractions? The answer is YES.

This is how we do it: Multiply the whole number (integer) by the denominator and add this answer to the numerator with the denominator staying the same.

$$\begin{aligned} & 2\frac{5}{6} \\ = & \frac{2 \times 6 + 5}{6} \\ = & \frac{12 + 5}{6} \\ = & \frac{17}{6} \end{aligned}$$

Alternative explanation:

$$\begin{aligned} 2\frac{5}{6} &= 2 + \frac{5}{6} \\ &= \frac{12}{6} + \frac{5}{6} \\ &= \frac{17}{6} \end{aligned}$$

3.2.3 Simplification of fractions

If both the numerator and the denominator of a fraction are multiplied or divided by the same number, the fraction does not change, as it still represents the same quantity.

To have a fraction in its simplest form, we want the smallest possible numbers in the numerator and denominator, and still have a fraction with the same value.

Example 3.4

$$\begin{array}{ll}
 \frac{6}{18} = \frac{2}{6} & \text{Divide both the denominator and the numerator by 3,} \\
 \text{and } \frac{2}{6} = \frac{1}{3} & \text{Divide both the denominator and the numerator by 2.} \\
 \frac{12}{16} = \frac{6}{8} & \text{Divide both the denominator and the numerator by 2,} \\
 \text{and } \frac{6}{8} = \frac{3}{4} & \text{Divide both the denominator and the numerator by 2.} \\
 \frac{18}{24} = \frac{9}{12} & \text{Divide both the denominator and the numerator by 2,} \\
 = \frac{3}{4} & \text{and then by 3.}
 \end{array}$$

The fractions in the example above have been simplified.

3.2.4 Multiplication of fractions

There are three simple steps to multiply fractions:

1. Multiply the numerators.
2. Multiply the denominators.
3. Simplify the fraction if needed.

Example 3.5

$$\begin{aligned}
 1. \quad & \frac{2}{3} \times \frac{5}{7} \\
 &= \frac{2 \times 5}{3 \times 7} \\
 &= \frac{10}{21}
 \end{aligned}$$

$$\begin{aligned}
 2. \quad & \frac{3}{4} \times \frac{2}{3} \\
 &= \frac{6}{12} \\
 &= \frac{1}{2}
 \end{aligned}$$

OR

We could first simplify the fractions by cross cancelation, which are allowed.

$$\begin{aligned}
 & \frac{3}{4} \times \frac{2}{3} \quad \text{2 divides into 4; and 3 divides into 3} \\
 &= \frac{1}{2}
 \end{aligned}$$

$$\begin{aligned}
 3. \quad & \frac{6}{15} \times \frac{5}{4} \\
 &= \frac{3}{3} \times \frac{1}{2} \quad \text{Divide 2 into 4 and 6; and 5 into 15} \\
 &= \frac{1 \times 1}{1 \times 2} \quad \text{We divided 3 into 3} \\
 &= \frac{1}{2}
 \end{aligned}$$

$$\begin{aligned}
 4. \quad & \frac{2}{3} \times \frac{4}{5} \times \frac{15}{20} \\
 &= \frac{1 \times 4 \times 5}{1 \times 5 \times 10} \quad \text{Divide 2 into 20; and divide 3 into 15} \\
 &= \frac{1 \times 2 \times 1}{1 \times 1 \times 5} \quad \text{Divide 5 into 5; and 2 into 4 and 10} \\
 &= \frac{2}{5}
 \end{aligned}$$

5.

$$\begin{aligned}
 & \frac{5a}{7} \times \frac{21}{15a^2} \\
 = & \frac{5a}{7} \times \frac{21}{15 \times a \times a} && \text{Divide } 5a \text{ into } 15a^2; \text{ and divide } 7 \text{ into } 21 \\
 = & \frac{3}{3a} && \text{Divide } 3 \text{ into } 3 \\
 = & \frac{1}{a}
 \end{aligned}$$

6.

$$5 \times \frac{3}{5}$$

Let us first change the 5 (an integer) into a fraction, with the numerator being 5 and, the denominator 1. We know that 5 divided by 1 is 5, so normally we write “5” and not “ $\frac{5}{1}$ ”. Now,

$$\begin{aligned}
 & \frac{5}{1} \times \frac{3}{5} \\
 = & 3
 \end{aligned}$$



3.2.5 Division of fractions

There are three simple steps to divide fractions:

1. Invert (turn around) the second fraction, and make the $\div$ sign a $\times$ sign.
2. Multiply the first fraction with the inverted second fraction.
3. Simplify the resulting fraction if possible.

$$\begin{aligned}
 & 5 \div 3 \\
 = & \frac{5}{1} \div \frac{3}{1} \\
 = & \frac{5}{1} \times \frac{1}{3} \\
 = & \frac{5}{3}
 \end{aligned}$$

**Example 3.6**

1. (a)

$$\begin{aligned} & \frac{4}{7} \div \frac{6}{14} \\ = & \frac{4}{7} \times \frac{14}{6} \\ = & \frac{2}{1} \times \frac{2}{3} \\ = & \frac{4}{3} \\ = & 1\frac{1}{3} \end{aligned}$$

(b)

$$\begin{aligned} & \frac{3}{4} \times \frac{8}{9} \\ = & \frac{1}{1} \times \frac{2}{3} \\ = & \frac{2}{3} \end{aligned}$$

(c)

$$\begin{aligned} & \frac{3}{8} \times \frac{16}{21} \times \frac{7}{10} \\ = & \frac{1}{1} \times \frac{2}{7} \times \frac{7}{10} \\ = & \frac{1}{1} \times \frac{1}{1} \times \frac{1}{5} \\ = & \frac{1}{5} \end{aligned}$$

(d)

$$\begin{aligned} & \frac{3a}{4b} \div \frac{12a}{14b} \\ = & \frac{3a}{4b} \times \frac{14b}{12a} \\ = & \frac{3}{4} \times \frac{14}{12} \\ = & \frac{1}{2} \times \frac{7}{4} \\ = & \frac{7}{8} \end{aligned}$$

(e)

$$\begin{aligned}
 & \frac{2}{3} \times \frac{4}{9} \div \frac{12}{15} \\
 = & \frac{2}{3} \times \frac{4}{9} \times \frac{15}{12} && \text{Only invert the term directly to the} \\
 & && \text{right-hand side of the division sign.} \\
 = & \frac{1}{1} \times \frac{4}{9} \times \frac{5}{6} \\
 = & \frac{1}{1} \times \frac{2}{9} \times \frac{5}{3} \\
 = & \frac{2 \times 5}{9 \times 3} \\
 = & \frac{10}{27}
 \end{aligned}$$

(f)

$$\begin{aligned}
 & \frac{5}{6} \div \frac{1}{12} \times \frac{3}{15} \\
 = & \frac{5}{6} \times \frac{12}{1} \times \frac{3}{15} && \text{Only invert the term directly to the} \\
 & && \text{right-hand side of the division sign.} \\
 = & 2
 \end{aligned}$$

(g)

$$\begin{aligned}
 & \frac{13b^2}{4a} \div \left(\frac{3b}{4a} \times \frac{8}{9} \right) \\
 = & \frac{13bb}{4a} \times \left(\frac{3a}{2b} \right) && \text{First do the brackets, and then} \\
 = & \frac{39b}{8} && \text{the division.}
 \end{aligned}$$

3.2.6 The addition and subtraction of fractions

We know that if we add $\frac{1}{4}$ to $\frac{1}{2}$, the answer is $\frac{3}{4}$. How did we get to this answer?

There are three simple steps to add fractions:

1. Make sure the denominators are the same (LCM).
2. Add the numerators of the fractions and put the answer over the denominator.
3. Simplify the fraction if possible.

So, how do we add $\frac{1}{4}$ to $\frac{1}{2}$?

We get the denominator to be the same by determining the LCM of the denominators:

$$\begin{aligned} 2 &= 2 \\ 4 &= 2 \times 2 \\ \text{LCM} &= 2 \times 2 \\ &= 4 \end{aligned}$$

Therefore

$$\begin{aligned} &\frac{1}{4} + \frac{1}{2} \\ &= \frac{1}{4} + \frac{2}{4} \\ &= \frac{2+1}{4} \\ &= \frac{3}{4}. \end{aligned}$$

Example 3.7

$$1. \frac{1}{4} + \frac{5}{6}$$

First determine the LCM of the denominators:

$$\begin{aligned} 4 &= 2 \times 2 \\ 6 &= 2 \times 3 \\ \text{LCM} &= 2 \times 3 \times 2 \\ &= 12 \end{aligned}$$

$$\begin{aligned} &\frac{1}{4} + \frac{5}{6} \\ &= \frac{1 \times 3 + 5 \times 2}{12} \\ &= \frac{3+10}{12} \\ &= \frac{13}{12} \\ &= 1\frac{1}{12} \end{aligned}$$

Alternative method:

$$\begin{aligned}
 & \frac{1}{4} + \frac{5}{6} \\
 = & \frac{3}{12} + \frac{10}{12} \\
 = & \frac{3+10}{12} \\
 = & \frac{13}{12} \\
 = & 1\frac{1}{12}
 \end{aligned}$$

2. $\frac{3}{5} + \frac{4}{7}$

First determine the LCM of the denominators:

$$\begin{aligned}
 5 &= 5 \\
 7 &= 7 \\
 \text{LCM} &= 5 \times 7 \\
 &= 35
 \end{aligned}$$

$$\begin{aligned}
 & \frac{3}{5} + \frac{4}{7} \\
 = & \frac{3 \times 7 + 4 \times 5}{35} \\
 = & \frac{21 + 20}{35} \\
 = & \frac{41}{35} \\
 = & 1\frac{6}{35}
 \end{aligned}$$

Alternative method:

$$\begin{aligned}
 & \frac{3}{5} + \frac{4}{7} \\
 = & \frac{3 \times 7}{35} + \frac{4 \times 5}{35} \\
 = & \frac{21}{35} + \frac{20}{35} \\
 = & \frac{41}{35} \\
 = & 1\frac{6}{35}
 \end{aligned}$$

3. $\frac{7}{9} + \frac{5}{6}$

Determine the LCM:

$$\begin{aligned}
 9 &= 3 \times 3 \\
 6 &= 2 \times 3 \\
 \text{LCM} &= 3 \times 3 \times 2 \\
 &= 18
 \end{aligned}$$

$$\begin{aligned}
 &= \frac{\frac{7}{9} + \frac{5}{6}}{\frac{7 \times 2 + 5 \times 3}{18}} \\
 &= \frac{14+15}{18} \quad \text{OR} \\
 &= \frac{29}{18} \\
 &= 1\frac{11}{18}
 \end{aligned}
 \qquad
 \begin{aligned}
 &= \frac{\frac{7}{9} + \frac{5}{6}}{\frac{14}{18} + \frac{15}{18}} \\
 &= \frac{29}{18} \\
 &= 1\frac{11}{18}
 \end{aligned}$$

To subtract one fraction from another, we basically take the same steps as for addition.

4. $\frac{13}{15} - \frac{2}{6}$

Determine the LCM:

$$\begin{aligned}
 15 &= 3 \times 5 \\
 6 &= 2 \times 3 \\
 \text{LCM} &= 3 \times 5 \times 2 \\
 &= 30
 \end{aligned}$$

$$\begin{aligned}
 &= \frac{\frac{13}{15} - \frac{2}{6}}{\frac{13 \times 2 - 2 \times 5}{30}} \\
 &= \frac{26-10}{30} \quad \text{OR} \\
 &= \frac{16}{30} \\
 &= \frac{8}{15}
 \end{aligned}
 \qquad
 \begin{aligned}
 &= \frac{\frac{13}{15} - \frac{2}{6}}{\frac{26}{30} - \frac{10}{30}} \\
 &= \frac{26-10}{30} \\
 &= \frac{16}{30} \\
 &= \frac{8}{15}
 \end{aligned}$$

5. $\frac{16a}{b} + \frac{9b}{c}$

Determine the LCM:

$$\text{LCM} = b \times c = bc$$

$$\begin{aligned}
 &= \frac{\frac{16a}{b} + \frac{9b}{c}}{\frac{16a \times c + 9b \times b}{bc}} \quad \text{OR} \\
 &= \frac{16ac+9b^2}{bc}
 \end{aligned}
 \qquad
 \begin{aligned}
 &= \frac{\frac{16a}{b} + \frac{9b}{c}}{\frac{16ac}{bc} + \frac{9bb}{bc}} \\
 &= \frac{16ac+9b^2}{bc}
 \end{aligned}$$

6. $\frac{1}{6} - \frac{3}{5}$

Determine the LCM:

$$\begin{aligned}
 5 &= 5 \\
 6 &= 2 \times 3 \\
 &= 30
 \end{aligned}$$

$$\begin{aligned}
 &= \frac{\frac{1}{6} - \frac{3}{5}}{1} \\
 &= \frac{1 \times 5 - 3 \times 6}{30} \\
 &= \frac{5 - 18}{30} \\
 &= \frac{-13}{30} \\
 &= -\frac{13}{30}
 \end{aligned}
 \quad \text{OR} \quad
 \begin{aligned}
 &= \frac{\frac{1}{6} - \frac{3}{5}}{1} \\
 &= \frac{5}{30} - \frac{18}{30} \\
 &= \frac{5 - 18}{30} \\
 &= \frac{-13}{30} \\
 &= -\frac{13}{30}
 \end{aligned}$$

7. $\frac{2}{5} + \frac{3}{6} - \frac{1}{4}$

Determine the LCM:

$$5 = 5$$

$$6 = 2 \times 3$$

$$4 = 2 \times 2$$

$$\text{LCM} = 5 \times 2 \times 3 \times 2$$

$$= 60$$

$$\begin{aligned}
 &\frac{2}{5} + \frac{3}{6} - \frac{1}{4} \\
 &= \frac{2(12) + 3(10) - 1(15)}{60}
 \end{aligned}$$

$$= \frac{24 + 30 - 15}{60}$$

$$= \frac{39}{60}$$

$$= \frac{13}{20}$$

OR

$$\begin{aligned}
 &\frac{2}{5} + \frac{3}{6} - \frac{1}{4} \\
 &= \frac{2(12)}{60} + \frac{3(10)}{60} - \frac{1(15)}{60}
 \end{aligned}$$

$$= \frac{24 + 30 - 15}{60}$$

$$= \frac{39}{60}$$

$$= \frac{13}{20}$$

8.

$$\begin{aligned}
 &2\frac{1}{2} + 1\frac{1}{2} \\
 &= 2 + 1 + \frac{1}{2} + \frac{1}{2} \quad \text{Separate the integers from the fractions} \\
 &= 3 + \frac{1(1) + 1(1)}{2} \quad \text{Add up the integers and simplify the two fractions.} \\
 &= 3 + \frac{1+1}{2} \\
 &= 3 + \frac{2}{2} \\
 &= 3 + 1 \\
 &= 4
 \end{aligned}$$

NB: We know that

$$\begin{aligned}
 &2 - \frac{1}{2} \\
 &= \frac{2 \times 2 - 1 \times 1}{2} \\
 &= \frac{4 - 1}{2} \\
 &= \frac{3}{2} \\
 &= 1\frac{1}{2}.
 \end{aligned}$$

Note: We may only cross cancel over a **multiplication** sign, not over a $-$ or a $+$.

It is **TOTALLY INCORRECT** to do the following:

$$\begin{array}{rcl}
 & \cancel{2} & \cancel{-} \quad \cancel{1} \\
 & \cancel{2} & \cancel{2} \\
 = & 1 & - 1 \\
 = & 0 &
 \end{array}$$

Cancel the 2 in the numerator by the 2 in the denominator.

You may only cancel out factors!

3.3 Decimals

A decimal system involves counting in units of 10. A decimal is a number consisting of a comma followed by one or more numbers which represent tenths, hundredths, and so on.

To change a fraction to a decimal, we have to divide the denominator into the numerator.

Example 3.8

1. Write $\frac{1}{2}$ as a decimal.

$$2 \overline{)1}$$

We cannot divide 2 into 1. So, we add a zero to the 1.

$$2 \overline{)1,0}$$

Because we have added the zero we have to write a comma above the division line.

$$2 \overline{)1,0} \\ 0,5$$

Now we can divide 2 into 10 to get 5. The answer is therefore 0,5. We usually write a zero in front of the comma.

2. Write $\frac{3}{4}$ as a decimal.

We have to divide 4 into 3,000 ...

$$4 \overline{)3,00} \\ 0,75 \\ \underline{28} \\ 20 \\ \underline{20} \\ 0$$

$$4 \times 7 = 28$$

Subtract 28 from 30 and add zero to the answer of 2

$$4 \times 5 = 20$$

Subtract 20 from 20 to get 0.

Therefore, $\frac{3}{4} = 0,75$.

3. Write the following as decimals:

(a) $\frac{1}{10}$

If we have to divide the numerator with 10, we just shift the comma in the numerator 1 unit to the left. Note that $1 = 1,0$.

Therefore, $\frac{1}{10} = 0,1$.

We usually write a zero in front of the comma.

(b) $\frac{1}{100} = 0,01$

If we have to divide the numerator with 100, we shift the comma in the numerator 2 units to the left.

Therefore, $\frac{1}{100} = 0,01$.

100 has 2 zeros therefore there are two numbers after the comma.

(c) $\frac{3}{100} = 0,03$.

Here again we shifted the comma in 3,0 two units to the left to get 0,03.

(d) $\frac{17}{1000} = 0,017$.

There are three zeros in the denominator of 1 000, therefore we shift the comma in the numerator 17 three units to the left to get 0,017.

(e) $\frac{4}{100000} = 0,00004$

There are five zeros in 100 000 therefore we shift the comma five unit to the left to get 0,00004.

You can use your calculator to check the answers.

4. Write $2\frac{1}{4}$ as a decimal.

To change a mixed fraction into a decimal, we do the following:

Write the $\frac{1}{4}$ as a decimal and add it to the integer (whole number).

$$2\frac{1}{4} = 2,25$$

3.4 Percentages

Percentage means per hundred. Five percent or 5% means 5 per hundred, which can be written as 5% of $\frac{5}{100}$ or 0,05.

33% means 33 out of a hundred or 0,33.

115% means $\frac{115}{100}$ or 1,15, etc.

Example 3.9

1. Tim would like to buy a bicycle that costs R1 200. His grandmother is prepared to give him 40% of the price of the bicycle as a birthday present. How much money will she give him?

$$\begin{aligned}\text{The amount received} &= 40\% \text{ of } 1\,200 \\ &= \frac{40}{100} \times \frac{1\,200}{1} \\ &= 480.\end{aligned}$$

His grandmother will give him R480.

2. John receives a commission of 2,5% on his sales. His monthly sales for December amounted to R175 000. Determine his commission.

$$\begin{aligned}\text{The amount of commission} &= \frac{2,5}{100} \times \frac{175\,000}{1} \\ &= 4\,375,00\end{aligned}$$

John's commission for December was R4 375,00.

3. Kate bought a dress, priced at R1 800, at Elegant Boutique. She was given a discount of 30%. How much did Kate pay for the dress?

$$\begin{aligned}\text{Discount} &= \frac{30}{100} \times \frac{1\,800}{1} \\ &= 540\end{aligned}$$

The amount paid for the dress is the original price of the dress, minus the discount:

$$\begin{aligned}\text{Price paid} &= 1\,800 - 540 \\ &= 1\,260\end{aligned}$$

Therefore, Kate paid R1 260 for the dress.

4. James received an increase of R1 200 per month on his monthly salary of R9 600. Determine the percentage increase in his salary.

$$\begin{aligned}\text{Increase} &= \frac{1\,200}{9\,600} \times \frac{100}{1} \\ &= 12,5\%\end{aligned}$$

The percentage increase was 12,5%.

5. You obtained 12 out of 15 for your first assignment. What is your mark as a percentage for this assignment?

$$\begin{aligned}\text{Percentage} &= \frac{12}{15} \times \frac{100}{1} \\ &= 80\%\end{aligned}$$

You obtained 80% for the first assignment.

6. Joseph bought a TV set that normally costs R2 500, for R2 000. Determine the percentage discount that Joseph received.

First determine the amount of discount that Joseph received:

That is $R(2\,500 - 2\,000) = R500$.

Remember that percentage is always calculated on the original amount.

$$\begin{aligned}\text{Percentage discount} &= \frac{500}{2\,500} \times \frac{100}{1} \\ &= 20,00\%\end{aligned}$$

Joseph received 20% discount.

3.5 Ratios

A ratio is a way of comparing two or more quantities.

Suppose we have a pupil - teacher ratio of 40 to 1. Then we can symbolically write, the pupil **to** teacher ratio is 40:1, or alternatively $\frac{40}{1}$. We read 40:1 as 40 to 1.

The order in which the numbers is written, is important. The 40 refers to the first object mentioned, namely the pupils, and the 1 refers to the second, namely, teachers.

Example 3.10

1. Albert has R10 000 which he wishes to divide between his two sisters, Alice and April in the ratio of 6:4. How much will each of the sisters receive?

First we determine the portion that Alice will receive, and then the portion that April will receive. If the money must be divided in the ratio of 6:4 we divide the money into 10 equal parts. ($10 = 6 + 4$).

Then

$$\begin{aligned}\text{Alice will receive} &= \frac{6}{10} \times \frac{\text{R}10\,000}{1} \\ &= 6\,000.\end{aligned}$$

$$\begin{aligned}\text{April will receive} &= \frac{4}{10} \times \frac{\text{R}10\,000}{1} \\ &= 4\,000.\end{aligned}$$

Alice will receive R6 000 and April R4 000.

Note: If you add the two amounts together you get R10 000 which is the original amount that had to be divided between the two sisters.

2. Jerome picked 77 apples and he wishes to divide them between Sipho and Simon in the ratio of 3:8. Determine how many apples Sipho will receive.

The total number of parts in the ratio is 11.

$$\begin{aligned}\text{Sipho will receive} &= \frac{3}{11} \times \frac{77}{1} \\ &= 21\end{aligned}$$

Sipho will receive 21 apples.

Measurements

On completion of this chapter you will be able to

- convert length units from one unit to another
- determine the perimeter of different figures
- determine the area of different figures
- determine the volume of different objects
- convert litres to cubic units
- convert cubic units to litres
- apply measurements to assist in decision-making in daily life problems

Have you ever renovated the tiling in the bathroom or kitchen of your home? If yes, then you will know that in order to do that, you had to decide how many tiles to buy. Were you able to determine the number of tiles needed or did you ask someone else?

In this chapter we start off by showing you the basics of measurement. This will enable you to tackle problems similar to the ones described above (and others) with confidence. It will place you in a position where you do the calculations and make the decisions yourself.

4.1 The international system

It is difficult to imagine a world without a system for measuring things. You would not know the distance to another town, the capacity in litres of a fuel tank, whether your body mass is within limits, and so on.

The earliest measuring system originated in the barter system and units corresponded with things like the length or size of a hand or foot. Many countries each had their own measuring system. In the modern world, which is characterised by international trade and extended industrial and technological development, it became necessary to have a common measuring system. A modern international system, the *Système international d'unités*, also known as SI, was developed. South Africa was one of the first countries to accept this system.

The following table gives us a good indication of the SI system:

Factor	Power	Common name	SI name	SI symbol
10	10^1	ten	deca-	D
100	10^2	hundred	hecto-	h
1 000	10^3	thousand	kilo-	k
1 000 000	10^6	million	mega-	M
0,1	10^{-1}	tenth	deci-	d
0,01	10^{-2}	hundredth	centi-	c
0,001	10^{-3}	thousandth	milli-	m
0,000001	10^{-6}	millionth	micro-	μ

4.2 Length

The SI base unit for length is **metre**. The symbol used for this base unit is **m**. Therefore we write 10 metres as 10 m. Note the space between the number and the unit.

Decimal multiples and submultiples in the SI system are:

10	millimetres	(mm)	=	1	centimetre	(cm)
10	centimetres	(cm)	=	1	decimetre	(dm)
10	decimetres	(dm)	=	1	metre	(m)
10	meters	(m)	=	1	decametre	(Dm)
10	decametres	(Dm)	=	1	hectometre	(hm)
10	hectometres	(hm)	=	1	kilometre	(km)

In the SI system it is very easy to convert from one unit to another because we work in multiples of ten.

The rule is:

- If you have to convert to a greater unit, say from m to km, *divide* by the appropriate multiple of 10.
- If you have to convert to a smaller unit, say from m to mm, *multiply* by the appropriate multiple of 10.

We normally use km, m, cm and mm.

$$1 \text{ km} = 1\,000 \text{ m} \quad \text{and} \quad 1 \text{ m} = 100 \text{ cm} = 1\,000 \text{ mm}$$

“Distance” is a length. Examples of units used for distances are

- kilometres to measure long distances, like between cities, say 63 km
- metres to measure medium-sized distances, like your height, say 1,6 m
- centimetres to measure small lengths, like your body measurements, say your waist is 80 cm
- millimetres to measure very small lengths or thicknesses, like the width of a paper clip, say 6 mm.

Example 4.1 Convert the length of a 2,5 km tunnel into centimetres.

The first step is to change 2,5 km into metres by multiplying the number of kilometres by 1 000:

$$2,5 \text{ km} = 2,5 \times 1\,000 \text{ m} = 2\,500 \text{ m}$$

Therefore,

$$2,5 \text{ km} = 2\,500 \text{ m.}$$

The second step is to change 2 500 m into centimetres by multiplying the number of metres by 100:

$$2\,500 \text{ m} = 2\,500 \times 100 \text{ cm} = 250\,000 \text{ cm}$$

The length of the tunnel is thus 250 000 cm.

4.3 Perimeter

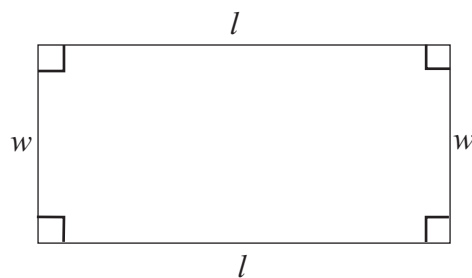
The perimeter C of a figure is the distance around the edge or boundary of a figure (the length of the boundary). We know that distance is measured as a length, therefore, we would use the same SI units for length to measure perimeter.

A home owner who wants to fence his or her property would, for example, measure the perimeter of the property to know how much fencing he or she needs.

To measure the perimeter of a regular figure we usually make use of the properties of the specific regular figure to simplify the calculations. Let us look at a rectangle, a square, a triangle and a circle.

4.3.1 Rectangles

A rectangle is a four-sided figure with all four angles equal to 90° and the opposite sides equal in length.



The little squares in the corners of the figure above indicate that the angles are 90° . Suppose the long sides of the rectangle are of length l and the short sides are of length w . We call them the length and width of the rectangle.

The perimeter of the rectangle is the sum of all four sides:

$$\begin{aligned} C &= l + w + l + w \\ &= 2l + 2w \\ &= 2(l + w) \end{aligned}$$

The formula for the **perimeter of a rectangle** is

$$C = 2(l + w).$$

Therefore, to calculate the perimeter of the rectangle, we add the long side of the rectangle to the short side of the rectangle and multiply this sum with two.

Example 4.2

Calculate the perimeter of a rectangle with a length of 10 m and a width of 4 m.

The first step is to add the long side of 10 m to the short side of 4 m to get the sum of 14 m. Secondly, multiply this sum with two to get the perimeter of 28 m.

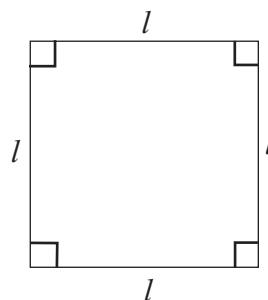
Mathematically we write this as

$$\begin{aligned} C &= 2(l + w) \\ &= 2(10 + 4) \\ &= 2(14) \\ &= 28 \end{aligned}$$

The perimeter is 28 m.

4.3.2 Squares

A square is a rectangle with all four sides equal in length, l .



The perimeter is the sum of all four sides:

$$\begin{aligned} C &= l + l + l + l \\ &= 4l \end{aligned}$$

The formula for the **perimeter of a square** is

$$C = 4l.$$

Example 4.3

Calculate the perimeter of a square with sides of 7 cm.

Multiply the side length by four to get the perimeter of 28 cm.

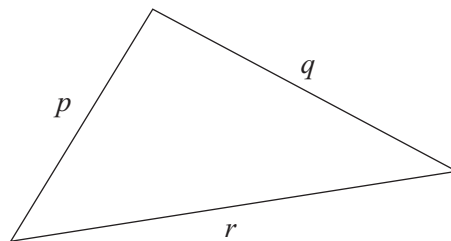
Mathematically we write it as

$$\begin{aligned} C &= 4l \\ &= 4 \times 7 \\ &= 28. \end{aligned}$$

The perimeter is 28 cm.

4.3.3 Triangles

A triangle is a three-sided figure.



Again the perimeter is the sum of the lengths of the sides.

$$C = p + q + r$$

Example 4.4

Calculate the perimeter of a triangle with sides of 3 cm, 5 cm and 7 cm.

Add lengths of the three sides together to get the perimeter of 15 cm.

Mathematically we write it as

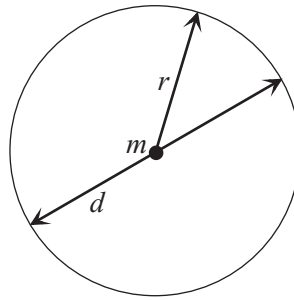
$$\begin{aligned} C &= 3 + 5 + 7 \\ &= 15 \end{aligned}$$

The perimeter is 15 cm.

4.3.4 Circles

Note: We refer to the perimeter of a circle as the **circumference** of a circle.

A circle is a perfectly round plane figure in which every point on its circumference is equidistant from its centre. (“Equidistant” means the same distance from the centre of the circle.)



We call the distance from the centre (m) to the circumference the **radius** (r) of the circle. The **diameter** (d) is the straight line from side to side passing through the centre (m). The diameter (d) is two times as long as the radius (r), therefore $d = 2r$.

The irrational number π (pronounced 'pie') is the ratio of the circumference of a circle to its diameter.

The formula for the **circumference** (C) of a circle is

$$C = 2\pi r.$$

Note: We use the π key on the calculator in calculations because it is more accurate than $\frac{22}{7}$.

Example 4.5

Calculate the circumference of a circle with a radius of 2 cm.

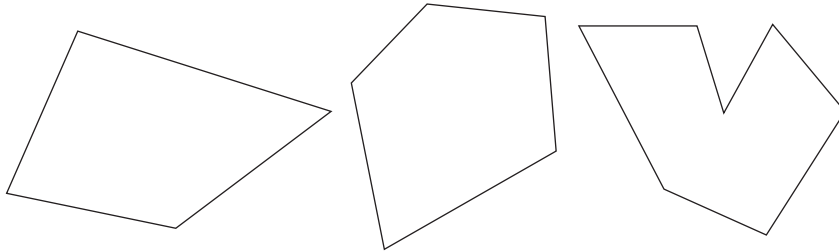
Using the given formula, the circumference is calculated as

$$\begin{aligned} C &= 2\pi r \\ &= 2 \times \pi \times 2 \\ &\approx 12,57 \end{aligned}$$

Therefore, the circumference of the circle is 12,57 cm.

4.3.5 Irregular figures

Here are some examples of irregular figures:



The perimeter is simply the sum of the lengths of all the sides.

Example 4.6

Calculate the perimeter of an irregular figure with five sides of length 2 m, 4 m, 5 m, 6 m and 3 m.

Add the lengths of the five sides together to get the perimeter of 20 m.

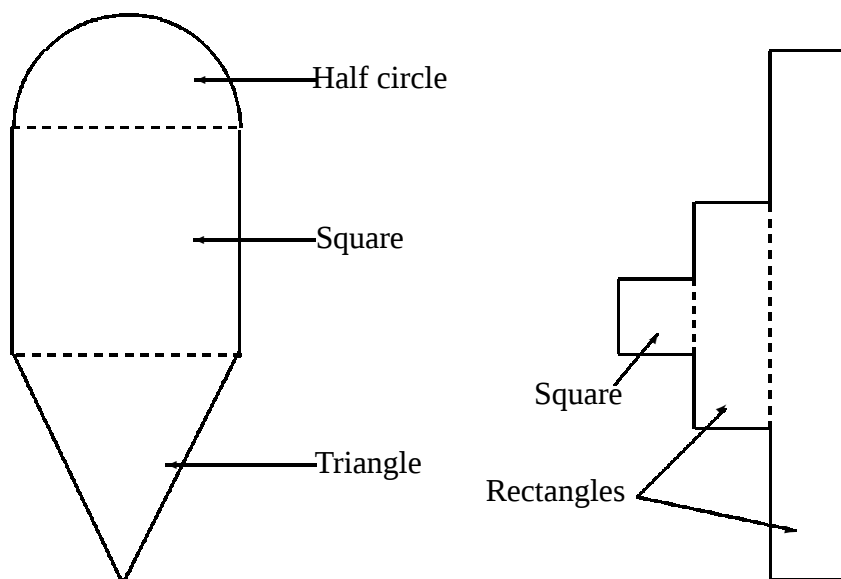
Mathematically we write it as

$$\begin{aligned} C &= 2 + 4 + 5 + 6 + 3 \\ &= 20 \end{aligned}$$

The perimeter is 20 m.

4.3.6 Composite figures

A composite figure is a combination of regular figures. Here are two examples:

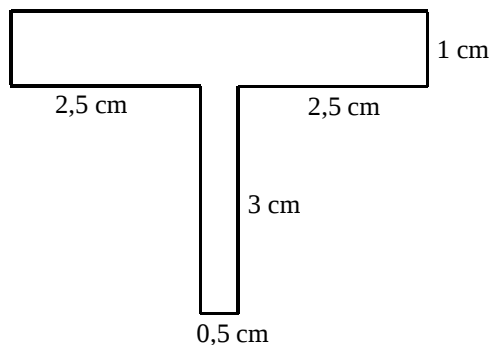


Again the perimeter is the sum of the lengths of all the sides.

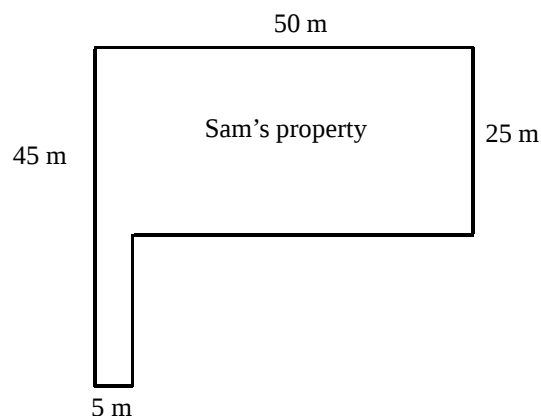

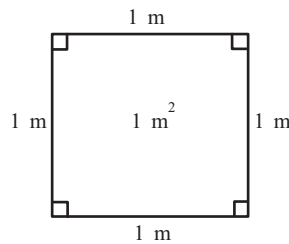

4.4 Area

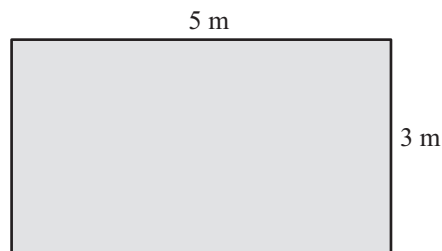
Area (A) is the word for the size of a surface. To specify the size of the surface we calculate the area of the surface.

The basic SI unit which is used for area is square metre (m^2). One square metre is the size of a square where each side of a square is one metre in length.



4.4.1 Rectangles

Suppose we want to tile a rectangular surface area which is 5 m long and 3 m wide.

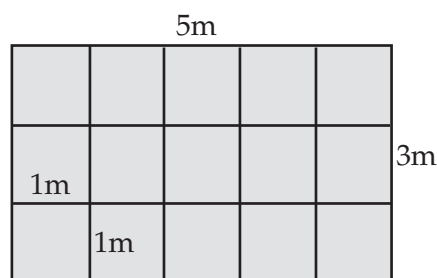


Furthermore, suppose we want to use big square tiles with side lengths 1 m.

The surface area of one tile is $1 \text{ m} \times 1 \text{ m} = 1 \text{ m}^2$.

(Remember our rules for multiplication: $1 \times 1 = 1$ and $\text{m} \times \text{m} = \text{m}^2$.)

Now, how many of these tiles do we need to cover the surface area of $5 \text{ m} \times 3 \text{ m}$? (We say 5 m *by* 3 m.)



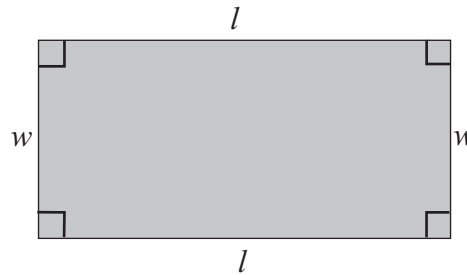
It is clear that we need 5 tiles in the length and 3 tiles in the width.

The number of tiles needed is $5 \times 3 = 15$.

We can now say that the area is 15 square metres.

(Also $5 \text{ m} \times 3 \text{ m} = 15 \text{ m}^2$.)

Thus, to calculate the area of a rectangle, we multiply the length by the width and give the answer as a “square ...”. The unit following the “square” will depend on the unit we are working with.



The formula for the **area (A) of a rectangle** is

$$\begin{aligned} A &= \text{length} \times \text{width} \\ &= l \times w. \end{aligned}$$

Instead of saying the length is x and the width is y , we talk about a rectangle of size x **by** y and write $x \times y$.

When the numbers become large, it is convenient to convert to a larger unit as the next example shows.

Example 4.7

To calculate the area of a rectangle of size $1\,000 \text{ m} \times 1\,000 \text{ m}$ we do the following:

$$\begin{aligned} A &= 1\,000 \text{ m} \times 1\,000 \text{ m} \\ &= 1\,000\,000 \text{ m}^2. \end{aligned}$$

The area is $1\,000\,000 \text{ m}^2$.

Instead of working with $1\,000\,000 \text{ m}^2$, we convert the $1\,000 \text{ m}$ to km . We know that $1\,000 \text{ m}$ is equal to 1 km therefore:

$$\begin{aligned} A &= 1\,000 \text{ m} \times 1\,000 \text{ m} \\ &= \frac{1\,000}{1\,000} \text{ km} \times \frac{1\,000}{1\,000} \text{ km} \\ &= 1 \text{ km} \times 1 \text{ km} \\ &= 1 \text{ km}^2 \end{aligned}$$

So we have $1\,000\,000 \text{ m}^2 = 1 \text{ km}^2$.

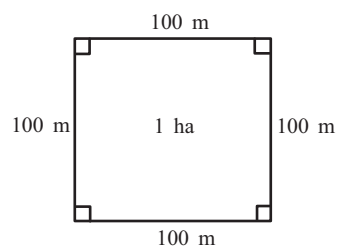
Other units we use for area are square metres, square centimetres, etc.

$$\begin{aligned}
 1\text{ m}^2 &= 1\text{ m} \times 1\text{ m} \\
 &= 100\text{ cm} \times 100\text{ cm} \\
 &= 10\,000\text{ cm}^2 \\
 &\text{and}
 \end{aligned}$$

$$\begin{aligned}
 1\text{ cm}^2 &= 1\text{ cm} \times 1\text{ cm} \\
 &= 10\text{ mm} \times 10\text{ mm} \\
 &= 100\text{ mm}^2
 \end{aligned}$$

When we are talking about land and its size, even km^2 will result in large numbers. For this purpose we use a hectare (ha).

A **hectare** is the area of a square, with each side of length 100 m.



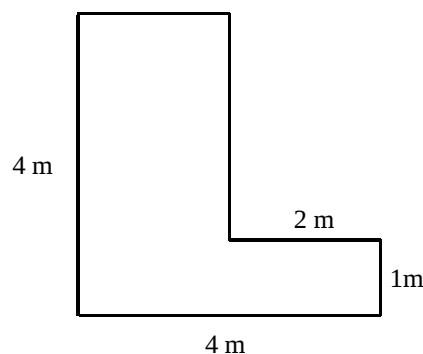
Thus

$$\begin{aligned}
 1\text{ ha} &= 100\text{ m} \times 100\text{ m} \\
 &= 10\,000\text{ m}^2.
 \end{aligned}$$

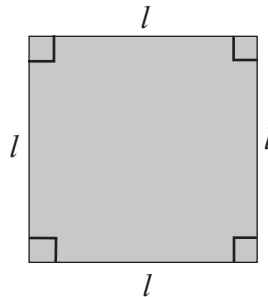

4.4.2 Squares

A square is a special type of rectangle with sides of equal length l .



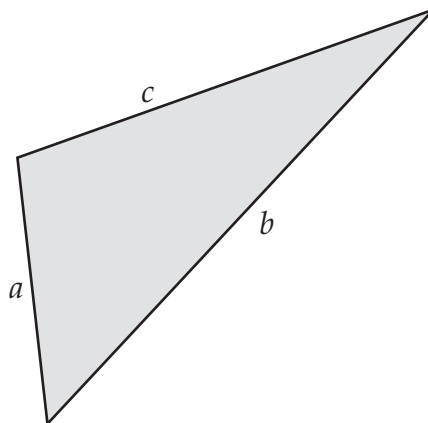
Therefore, the area of a square can easily be derived from the area formula for rectangles by substituting the width with length l .

The formula for the **area (A) of a square** is

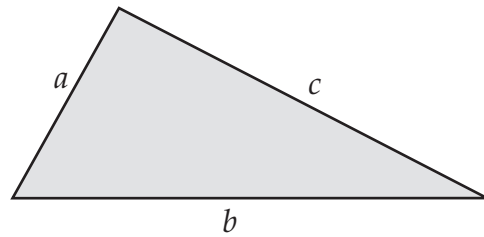
$$\begin{aligned} A &= \text{length} \times \text{length} \\ &= l \times l \\ &= l^2 \end{aligned}$$

4.4.3 Triangles

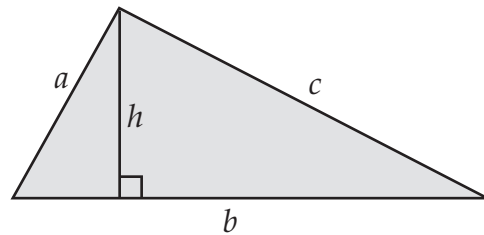
Calculating the area of a triangle is a little more complicated, but we can make it easier by using a sketch. Use any triangle and call the sides a , b and c .



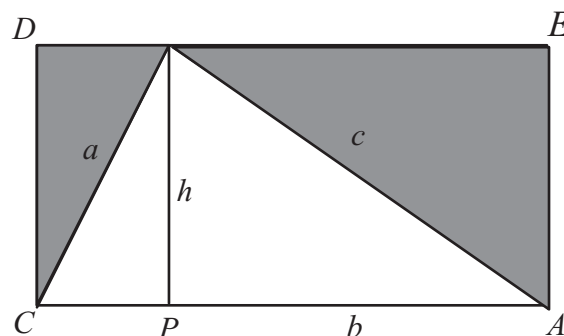
Now turn the triangle so that we can use any side as the base. Let us use side b .



Draw a line from the top vertex (angular point) perpendicular to the base b , and call it h (for height).



Now draw a rectangle over this triangle by drawing a line parallel to the base b through the top of the triangle and two more lines parallel to h so that we have the following:



Call this rectangle $ACDE$. The original triangle is called ACB and is made up of two triangles, PCB and APB .

It is clear that the triangle PCB is exactly one half of the rectangle $DBPC$, and the triangle APB is one half of rectangle $BEAP$. This means that the area of the triangle ACB is exactly one half that of the rectangle $ACDE$.

The area of the rectangle $ACDE = AC \times CD$.

But $CD = EA = h$, therefore the area of the rectangle is $b \times h$.

Therefore, the area of $ACDE = b \times h$.

We have already found that the area of the triangle is half that of the rectangle $ACDE$.

Therefore, the formula for **the area of a triangle** is

$$\begin{aligned} A &= \frac{1}{2} \text{base} \times \text{height} \\ &= \frac{1}{2} b \times h. \end{aligned}$$

Example 4.8

Calculate the area of a triangle with base 9,3 mm and height 7,6 mm.

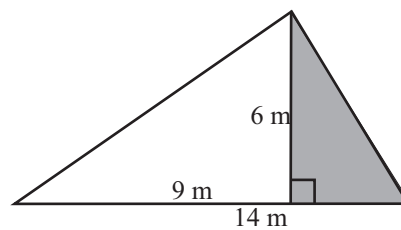
The area of a triangle is

$$\begin{aligned} A &= \frac{1}{2} b \times h \\ &= \frac{1}{2} \times 9,3 \times 7,6 \\ &\approx 35,34 \end{aligned}$$

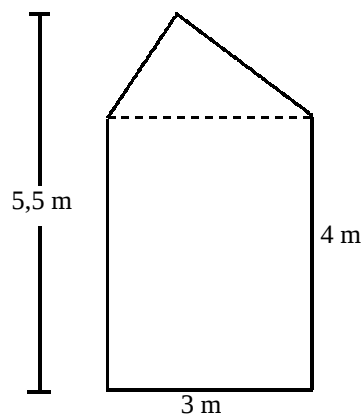
The area of the triangle is 35,34mm².

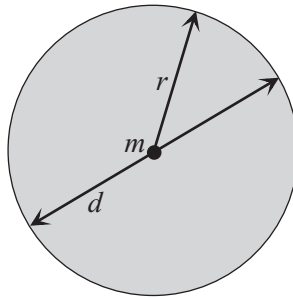

4.4.4 Circles

The formula for the area of a circle is

$$A = \pi r^2.$$



How this formula is arrived at is not important in this module. Let us look at an example.

Example 4.9

Calculate the area of a circle with radius 3 m.

The area of the circle is:

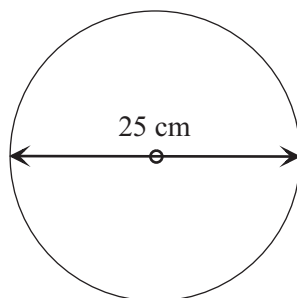
$$\begin{aligned} A &= \pi r^2 \\ &= \pi(3)^2 \\ &= \pi \cdot 9 \\ &\approx 28,27 \end{aligned}$$

The area is 28,27 m².

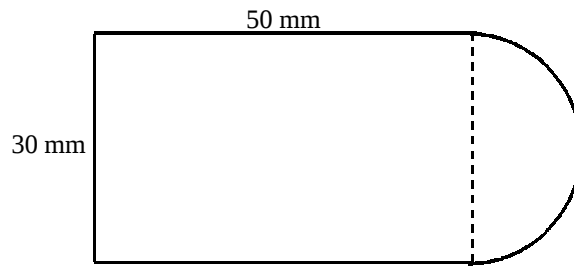

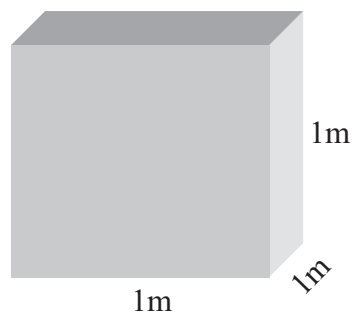

4.5 Volume

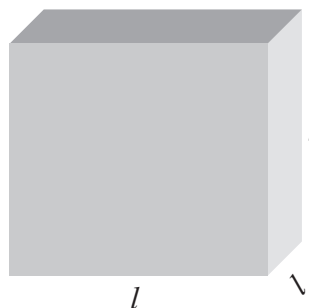
Volume (V) is the word used for the capacity of a three-dimensional object.

The basic SI unit for volume is **cubic metre (m^3)**. The volume of a cube, with each side's length one metre, is **one cubic metre**.



4.5.1 Cubes

A cube is a block with sides all equal in length, that means its length, width and height are all equal in length.

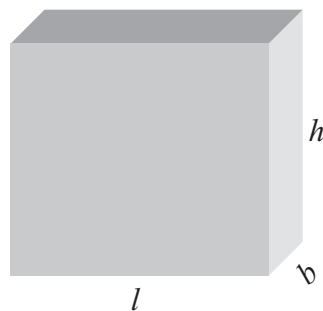


The formula for the **volume (V) of a cube** is:

$$\begin{aligned} V &= l \times l \times l \\ &= l^3 \end{aligned}$$

4.5.2 Prisms

In a rectangular prism the length, width and height can be of different lengths.

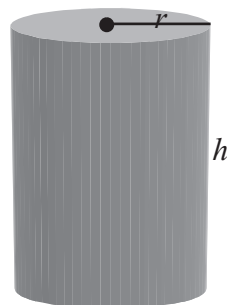


The formula for the **volume (V) of a prism** is:

$$\begin{aligned} V &= \text{area of the base} \times \text{perpendicular height} \\ &= l \times b \times h \end{aligned}$$

4.5.3 Cylinders

A cylinder is any object that has circles at its base and top and has a perpendicular height that joins the top and base.



The formula for the **volume of a cylinder** is:

$$\begin{aligned} V &= \text{area of base} \times \text{perpendicular height} \\ &= \pi r^2 \times h \\ &= \pi r^2 h \end{aligned}$$

4.5.4 Conversions and litres

Volume units other than m^3 (cubic metres) are also used. It is easy to convert from one unit to another in the SI system as we work in multiples of ten.

To convert from cm^3 to mm^3 :

$$\begin{aligned} 1 \text{ cm}^3 &= 1 \text{ cm} \times 1 \text{ cm} \times 1 \text{ cm} \\ &= 10 \text{ mm} \times 10 \text{ mm} \times 10 \text{ mm} \\ &= 1\,000 \text{ mm}^3 \end{aligned}$$

In words: One cubic centimetre is equal to a thousand cubic millimetres.

Therefore, to convert from cm^3 to mm^3 we must **multiply** by 1 000, and to convert from mm^3 to cm^3 we must **divide** with 1 000.

To convert from m^3 to cm^3 :

$$\begin{aligned} 1 \text{ m}^3 &= 1 \text{ m} \times 1 \text{ m} \times 1 \text{ m} \\ &= 100 \text{ cm} \times 100 \text{ cm} \times 100 \text{ cm} \\ &= 1\,000\,000 \text{ cm}^3 \end{aligned}$$

In words: One cubic metre is equal to a million cubic centimetres.

Therefore, to convert from m^3 to cm^3 we must **multiply with 1 000 000**, and to convert from cm^3 to m^3 we must **divide with 1 000 000**.

Another unit often used to measure volume is **litre**. Internationally, the abbreviation for litre is L, but in South Africa we use ℓ .

$$1 \ell = 10 \text{ cm} \times 10 \text{ cm} \times 10 \text{ cm} = 1\,000 \text{ cm}^3.$$

Therefore, to change from **litre to cm^3** we must **multiply with 1 000**. To change from cm^3 to ℓ we must **divide with 1 000**.

$$\begin{aligned}
 1\text{ m}^3 &= 1\text{ m} \times 1\text{ m} \times 1\text{ m} \\
 &= 100\text{ cm} \times 100\text{ cm} \times 100\text{ cm} \\
 &= 1\,000\,000\text{ cm}^3 \\
 &= \frac{1\,000\,000}{1\,000}\ell \\
 &= 1\,000\ell.
 \end{aligned}$$

Therefore,

$$1\text{ m}^3 = 1\,000\ell.$$

To change from m^3 to litre, we **multiply** by 1 000.

Example 4.10

1. Determine the volume of a cube with sides 50 mm long.
Give the answer in cm^3 .

The volume of the cube is:

$$\begin{aligned}
 V &= 50 \times 50 \times 50 \\
 &= 125\,000.
 \end{aligned}$$

The volume is $125\,000\text{ mm}^3$.

We know that $1\,000\text{ mm}^3 = 1\ell$.

Therefore to change the volume to cm^3 , divide with 1 000.

Thus

$$\begin{aligned}
 V &= 125\,000 \div 1\,000 \\
 &= 125.
 \end{aligned}$$

The volume is 125 cm^3 .

Alternatively, first convert the side lengths from mm to cm to get

$$\begin{aligned}
 V &= 50\text{ mm} \times 50\text{ mm} \times 50\text{ mm} \\
 &= 5\text{ cm} \times 5\text{ cm} \times 5\text{ cm} \quad (10\text{ mm} = 1\text{ cm}) \\
 &= 125\text{ cm}^3
 \end{aligned}$$

2. Determine the volume of a prism with $l = 2\text{ m}$, $b = 3\text{ m}$ and $h = 3\text{ m}$.
Give the answer in litres.

The volume of the prism is:

$$\begin{aligned}
 V &= l \times b \times h \\
 &= 2 \times 3 \times 3 \\
 &= 18.
 \end{aligned}$$

The volume is 18 m^3 .

To change the volume to litres, multiply with 1 000 because

$1\text{ m}^3 = 1\,000\ell$. Thus

$$\begin{aligned} V &= (18 \times 1\,000) \\ &= 18\,000 \end{aligned}$$

The volume is 18 000 litres.

3. Determine the volume of a water pipe which is 2 km long with a radius of 25 cm. Give the answer in litres.

First convert all the measurements to the same units:

$$\begin{aligned} 2\text{ km} &= 2\,000\text{ m} \\ &= (2\,000 \times 100)\text{ cm} \\ &= 200\,000\text{ cm} \end{aligned}$$

The volume of the water pipe, which is in the form of a cylinder, is

$$\begin{aligned} V &= \pi r^2 h \\ &= \pi (25)^2 \times 200\,000 \\ &= \pi \cdot 125\,000\,000 \\ &\approx 392\,699\,081,7 \end{aligned}$$

The volume of the water pipe is thus $392\,699\,081,7\text{ cm}^3$.

To convert this volume to litres, we divide by 1 000. The volume is thus 392 699 litres. └

4.6 Summary of formulas

Perimeter

Rectangle: $C = 2(l + w)$

Square: $C = 4l$

Triangle: $C = a + b + c$

Circle: $C = 2\pi r$

Area

Rectangle: $A = l \times w$

Square: $A = l^2$

Triangle: $A = \frac{1}{2}bh$

Circle: $A = \pi r^2$

Volume

Cube: $V = l^3$

Prism: $V = l \times b \times h$

Cylinder: $V = \pi r^2 h$

4.7 Applications

Now that you have mastered the basics of measurement, we are going to apply it to problems encountered in our daily lives. These problems usually demand some type of decision from us: how many tiles to buy, how often to phone the oil recycling company, and so on. From what you have learned you will be in a position to confidently make such decisions. The following examples will illustrate different applications.

Example 4.11

1. You want to tile your lounge floor of size 5,0 m by 2,5 m. How many tiles are needed if the tiles are 250 mm by 250 mm? Add 10% for breakage.

The area of the floor is a rectangle and thus we can calculate it as:

$$\begin{aligned} A &= l \times w \\ &= 2,5 \times 5,0 \\ &= 12,5 \end{aligned}$$

The area of the lounge floor is 12,5 m².

Since we have to use the same unit right through, we need to calculate the area of one square tile in m². To do that we convert the side length of the tile from **mm to m**.

$$\begin{aligned}
 \text{Remember } 1\,000\text{ mm} &= 1\text{ m} \\
 \text{Therefore } 250\text{ mm} &= \frac{250}{1\,000}\text{ m} \\
 &= 0,25\text{ m}.
 \end{aligned}$$

The area of one tile is thus:

$$\begin{aligned}
 A &= l^2 \\
 &= (0,25)^2 \\
 &= 0,0625.
 \end{aligned}$$

The area of one tile is thus $0,0625\text{ m}^2$.

To get the number of tiles needed we divide the floor area by the area of one tile. (Remember the area of the floor and tile must be in the same units!)

$$\begin{aligned}
 \text{Number of tiles} &= \frac{12,5}{0,0625} \\
 &= 200
 \end{aligned}$$

Thus, 200 tiles will cover the $5\text{ m} \times 2,5\text{ m}$ floor.

To provide extra tiles for possible breakage, we add 10% therefore,

$$\begin{aligned}
 \text{the total number of tiles} &= 200 + 10\% \text{ of } 200 \\
 &= 200 + \frac{10}{100} \times 200 \\
 &= 200 + 20 \\
 &= 220.
 \end{aligned}$$

The number of tiles we need to purchase is 220.

2. How much will it cost to fill your swimming pool to the brim if the pool is in the form of a prism of size 6 m by 4 m by 2 m? You can buy water at R5 per kilolitre.

First we calculate the volume of the swimming pool:

$$\begin{aligned}
 V &= l \times b \times h \\
 &= 6 \times 4 \times 2 \\
 &= 48
 \end{aligned}$$

The volume of the swimming pool is 48 m^3 , which is 48 kilolitre.

As discussed in the section on volume, we know that

$$1 \text{ m}^3 = 1\,000 \ell = 1 \text{ kilolitre}$$

1 kilolitre cost R5, therefore, the cost to fill the pool is as follows:

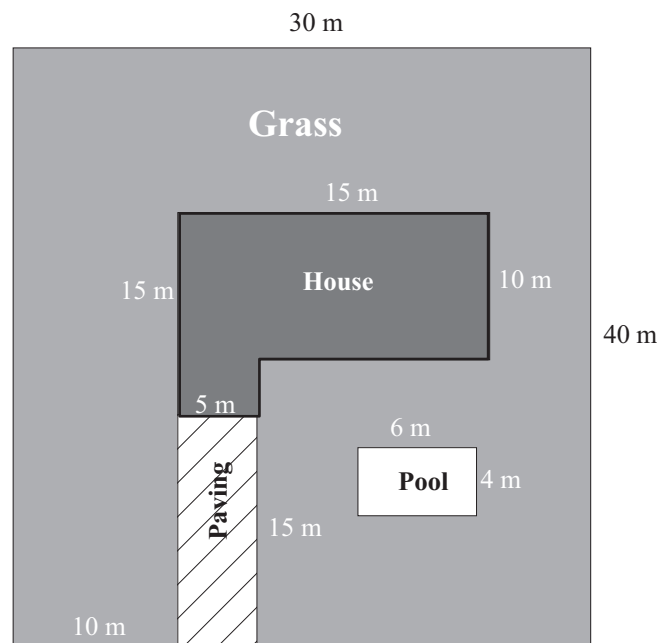
$$\begin{aligned} \text{cost} &= \text{price per kilolitre} \times \text{number of kilolitre used} \\ &= 5 \times 48 \\ &= 240 \end{aligned}$$

It will cost R240 to fill your swimming pool to the brim.

Equations and formulas

On completion of this chapter you will be able to

- manipulate equations

5.1 What are expressions, equations and formulas?

An expression is a combination of numbers, operators, brackets and variables for example:

$$3x - 6, 2 \times 5, \text{ and } 2(3x - 5)$$

An *equation* states that two expressions are equal to each other.

For example: $2x + 3 = 9$.

An equation always contains an equal sign.

A *formula* is a specific expression which represents the *relationship between different variables*. It is, in fact, a recipe for calculating the value of some desired variable, called the *dependent* variable, from the values of the relevant *independent* variables.

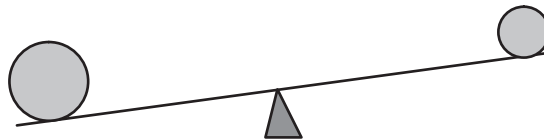
You are familiar with the use of formulas by now, because we have used formulas throughout Chapter 4.

In this chapter you will learn how to manipulate equations to solve them and how to change the subject of a formula.

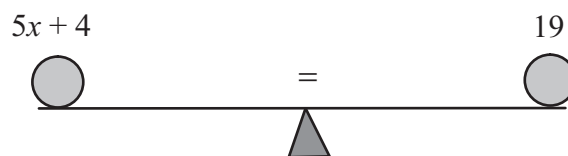
5.2 Manipulation and solving of equations

How do we solve for x in the equation $5x + 4 = 19$?

Think back to a see-saw from your childhood.



We have said that in an equation the left-hand side (LHS) is exactly equal to the right-hand side (RHS). That means that our see-saw must be in balance with the $=$ sign directly above the point of support, ▲.



If we want to solve for x , we manipulate the equation by getting rid of everything on the left-hand side of the equation, so that we have only the x on the left. But remember: our see-saw must stay in balance because of the equal sign. Therefore,

Whatever you do on the left-hand side of the equation, you must do the same on the right-hand side as well.

Now back to the original question.

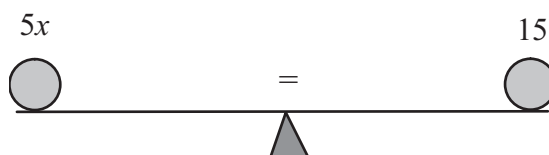
Solve $5x + 4 = 19$.

We go step-by-step to get the x alone on the left.

First take away (subtract) the 4. On both sides!

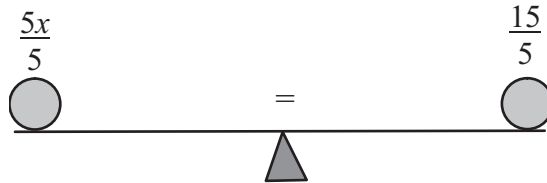


Thus

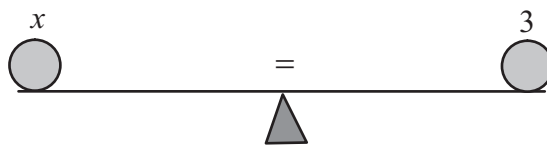


You can see that our see-saw is still in balance. The see-saw has to stay in balance right through our manipulation.

If we want to solve x we are still stuck with the 5. To get rid of the 5, we can divide (both sides!) by 5.



Thus



To check our answer we can substitute $x = 3$ in the original equation.

$$\begin{aligned}
 \text{LHS} &= 5x + 4 \\
 &= 5(3) + 4 \\
 &= 15 + 4 \\
 &= 19 \\
 \text{RHS} &= 19
 \end{aligned}$$

Therefore, the right hand-side is equal to the left hand-side if we substitute x with 3. Therefore, our answer of $x = 3$ is correct! That means, the equation $5x + 4 = 19$, is true if $x = 3$.

Now let us take this solving of a variable step-by-step.

Example 5.1

Solve the following equations:

1.

$$b + 4 = 9$$

To solve for b subtract 4 on both sides. Thus

$$\begin{aligned}
 b + 4 - 4 &= 9 - 4 \\
 b &= 5.
 \end{aligned}$$

The value of b is 5. That means if $b = 5$, the equation

$$b + 4 = 9$$

is true.

2.

$$p - 4 = 9$$

To solve for p add 4 on both sides. Thus

$$\begin{aligned} p - 4 + 4 &= 9 + 4 \\ p &= 13. \end{aligned}$$

The value of p is 13.

3.

$$4k = 24$$

To solve for k divide by 4 on both sides. Thus

$$\begin{aligned} \frac{4k}{4} &= \frac{24}{4} \\ k &= 6. \end{aligned}$$

The value of k is 6.

4.

$$\frac{k}{4} = 24$$

To solve for k multiply with 4 on both sides. Thus

$$\begin{aligned} \frac{k}{4} \times 4 &= 24 \times 4 \\ k &= 96. \end{aligned}$$

The value of k is 96. 

Check all four of these answers by substituting the answer in the original equation!

To summarise:

Apply the inverse basic operation on *both sides*.

The inverse operation for

- addition(+) is subtraction(−)
- subtraction(−) is addition(+)
- multiplication(×) is division(÷)
- division(÷) is multiplication(×).

Example 5.2

Solve the variable in each of the following equations:

1. $a + 3 = 5$

The operation on the left hand-side of the equation is addition. To solve the equation apply the inverse operation of subtraction, on both sides and simplify:

$$\begin{aligned}a + 3 &= 5 \\a + 3 - 3 &= 5 - 3 \\a &= 2\end{aligned}$$

The value of a is 2.

2. $b - 7 = 16$

To solve the equation apply the inverse operation of addition, on both sides:

$$\begin{aligned}b - 7 &= 16 \\b - 7 + 7 &= 16 + 7 \\b &= 23\end{aligned}$$

The value of b is 23.

3. $x - 2 = 6$

To solve the equation add 2 on both sides:

$$\begin{aligned}x - 2 &= 6 \\x - 2 + 2 &= 6 + 2 \\x &= 8\end{aligned}$$

The value of x is 8.

4. $3p = 14$

To solve the equation divide by 3 on both sides:

$$\begin{aligned}3p &= 14 \\\frac{3p}{3} &= \frac{14}{3} \\p &= 4\frac{2}{3}\end{aligned}$$

The value of p is $4\frac{2}{3}$.

5. $\frac{r}{5} = 4$

To solve the equation multiply by 5 on both sides:

$$\begin{aligned}\frac{r}{5} &= 4 \\ \frac{r}{5} \times \frac{5}{1} &= 4 \times 5 \\ r &= 20\end{aligned}$$

The value of r is 20.



Exercise 5.1

Our next step is to look at a combination of the basic operations. Let us look at some other examples.

Example 5.3

Solve for x .

$$2x - 3 = 5$$

Add 3 both sides and simplify.

$$\begin{aligned}2x - 3 + 3 &= 5 + 3 \\ 2x &= 8\end{aligned}$$

Divide both sides with 2.

$$\begin{aligned}\frac{2x}{2} &= \frac{8}{2} \\ x &= 4\end{aligned}$$

Thus x is 4.



Example 5.4

Solve for x .

$$\frac{x}{3} + 2 = 11$$

Subtract 2 both sides.

$$\begin{aligned}\frac{x}{3} + 2 - 2 &= 11 - 2 \\ \frac{x}{3} &= 9\end{aligned}$$

Multiply both sides with 3.

$$\begin{aligned}\frac{x}{3} \times \frac{3}{1} &= \frac{9}{1} \times \frac{3}{1} \\ x &= 27\end{aligned}$$

Thus x is 27.

Example 5.5

Solve for p .

$$7p + 5 = 33$$

Subtract 5 on both sides and simplify.

$$\begin{aligned}7p + 5 - 5 &= 33 - 5 \\ 7p &= 28\end{aligned}$$

Divide by 7 and simplify.

$$\begin{aligned}\frac{7p}{7} &= \frac{28}{7} \\ p &= 4\end{aligned}$$

Always remove the number *furthest* from the variable *first*.

Exercise 5.2

Solve the variables in the following equations. Always check your answer.

(a) $2x + 3 = 6$

Let us look at more complicated examples:

Example 5.6

Solve the following equations:

$$1. \quad 4 + 4x - 2 = 7$$

Add the constants on the left:

$$4x + 2 = 7$$

Subtract 2 on both sides:

$$4x = 5$$

Divide by 4 on both sides and simplify:

$$x = \frac{5}{4}$$

The value of x is $\frac{5}{4}$ or 1,25.

$$2. \quad 8x + 6 = 3x + 26$$

Subtracting $3x$ on both sides and simplify:

$$8x - 3x + 6 = 3x - 3x + 26.$$

$$5x + 6 = 26$$

Subtract 6 on both sides and simplify:

$$5x = 20$$

Divide by 5 on both sides and simplify:

$$x = 4.$$

$$3. \quad 2(x + 3) = 18$$

Let us look at the LHS separately:

$$\text{LHS: } 2(x + 3)$$

According to the order of operations (see 2.4 in Section 2.5.) we have to remove the brackets first. We cannot simplify what's in the brackets: the x and the 3 are not like terms. What we do is to multiply what is in front of the brackets with each term inside the brackets:

$$2(x + 3)$$

We get

$$\begin{aligned} 2 \times x + 2 \times 3 \\ = 2x + 6. \end{aligned}$$

Remember this simplification of a bracket, as you will use it often in solving equations. In general we have

$$a(b + c) = ab + ac.$$

Now back to our example.

$$\begin{aligned} 2(x + 3) &= 18 \\ 2x + 6 &= 18 \\ 2x &= 18 - 6 \\ 2x &= 12 \\ x &= 6 \end{aligned}$$

- (b) $6a + 3 + 1 = 4a - 8 - 3a$

5.3 Changing the subject of a formula

In formulas we usually have more than one variable. We can manipulate the formula so that we have another variable on the left. We call this manipulation “changing the subject”.

To change the subject of the formula, $v = u + at$, from v to u means we want to have u alone on the left hand side of the equation. To accomplish it we apply the inverse operation of addition to u on both sides.

That is

$$\begin{aligned} v &= u + at \\ v - u &= u - u + at \\ v - u &= at. \end{aligned}$$

But we want **only** u on the left, so subtract v on both sides:

$$\begin{aligned}v - v - u &= at - v \\-u &= at - v\end{aligned}$$

We multiply both sides by -1 to get rid of the minus sign in front of the u :

$$\begin{aligned}-(-u) &= -(at - v) \\u &= -at + v \\u &= v - at\end{aligned}$$

Now we have changed the formula to have u as the subject.

To change the subject of $v = u + at$ to a , we must remove the number or variable *furthest* from a first. In this case it is u . Thus

$$\begin{aligned}v - u &= u - u + at \\v - u &= at.\end{aligned}$$

We may switch the left-hand side and the right-hand side around at any time, because they are equal to each other. We do that to get a on the left. Thus

$$at = v - u.$$

To have only a on the left, we divide both sides by t

$$\begin{aligned}\frac{at}{t} &= \frac{v - u}{t} \\a &= \frac{v - u}{t}.\end{aligned}$$

Another important aspect concerning formulas is that of the dependent variable and the independent variable(s), as mentioned at the beginning of this chapter. The variable on the left is called the dependent variable and those on the right are the independent variable(s).

In the formula $v = u + at$, v is the dependent variable and u , a and t are the independent variables.

Example 5.7

Change the subject of the following formulas to the variable indicated:

1. Change the subject to y in:

$$2y - 3x = 4$$

Add $3x$ on both sides and simplify.

$$2y - 3x + 3x = 4 + 3x.$$

$$2y = 4 + 3x$$

Divide by 2 on both sides and simplify.

$$\begin{aligned}y &= \frac{4+3x}{2} \\&= 2 + \frac{3}{2}x\end{aligned}$$

Therefore, $y = \frac{3}{2}x + 2$.

2. Change the subject to y in:

$$y - mx - c = 0$$

Add c on both sides and simplify.

$$y - mx - c + c = 0 + c$$

$$y - mx = c$$

Add mx on both sides and simplify.

$$y - mx + mx = c + mx$$

$$y = mx + c$$

3. Change the subject to a in:

$$\sqrt{a} = b$$

Square on both sides.

$$(\sqrt{a})^2 = (b)^2$$

Simplify using the fact that $(\sqrt{a})^2 = a$

$$a = b^2$$

4. Change the subject to a in:

$$ab - c = d$$

Add c on both sides and simplify.

$$ab - c + c = d + c$$

$$ab = c + d$$

Divide by b on both sides and simplify.

$$\frac{ab}{b} = \frac{c+d}{b}$$

$$a = \frac{c+d}{b}.$$

5. Change the subject to y in:

$$\frac{x+y}{z} = t$$

Multiply by z on both sides and simplify.

$$\frac{x+y}{z} \cdot \frac{z}{1} = \frac{t}{1} \cdot \frac{z}{1}$$

$$x + y = tz$$

Subtract x on both sides and simplify:

$$x - x + y = tz - x$$

$$y = tz - x$$

6. Change the subject to b in:

$$\frac{\sqrt{a+b}}{t} = s$$

Multiply by t on both sides and simplify.

$$\frac{\sqrt{a+b}}{t} \times \frac{t}{1} = s \times t.$$

$$\sqrt{a+b} = st$$

Square on both sides and simplify.

$$(\sqrt{a+b})^2 = (st)^2$$

$$a+b = (st)^2$$

Subtract a on both sides and simplify.

$$a - a + b = (st)^2 - a$$

$$b = s^2t^2 - a$$

7. Change the subject to h in:

$$t = \frac{\sqrt{2h}}{a}$$

Multiply by a on both sides and simplify.

$$\frac{t}{1} \times \frac{a}{1} = \frac{\sqrt{2h}}{a} \times \frac{a}{1}$$

$$at = \sqrt{2h}$$

Switch the sides around.

$$\sqrt{2h} = at$$

Square on both sides and simplify.

$$(\sqrt{2h})^2 = (at)^2$$

$$2h = (at)^2$$

Divide by 2 on both sides and simplify:

$$\frac{2h}{2} = \frac{(at)^2}{2}$$

$$h = \frac{a^2t^2}{2}$$

8. Change the subject to x in:

$$x^2 = y$$

Take the square root on both sides and use the fact that $\sqrt{x^2} = x$.

$$\sqrt{x^2} = \sqrt{y}$$

$$x = \sqrt{y}$$

9. Change the subject to r in:

$$A = \frac{\pi r^2}{4}$$

Multiply by 4 on both sides and simplify.

$$4A = \pi r^2.$$

Switch the two sides around.

$$\pi r^2 = 4A$$

Divide by π on both sides and simplify.

$$r^2 = \frac{4A}{\pi}.$$

Take the square root on both sides.

$$\begin{aligned}\sqrt{r^2} &= \sqrt{\frac{4A}{\pi}}. \\ r &= \sqrt{\frac{4A}{\pi}}\end{aligned}$$

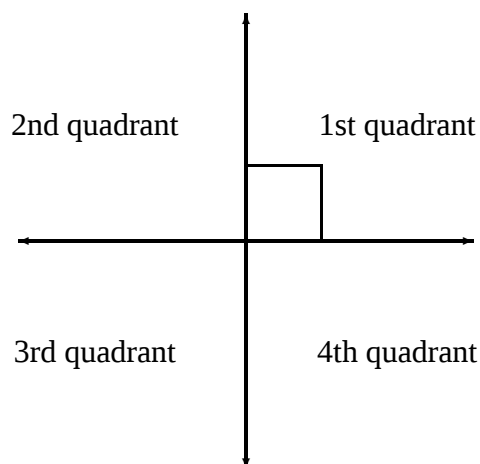

Straight lines

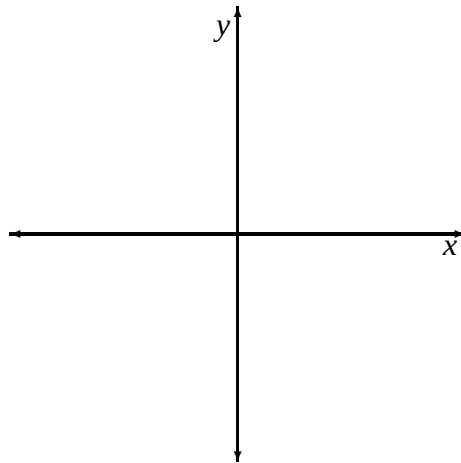
On completion of this chapter you should be able to

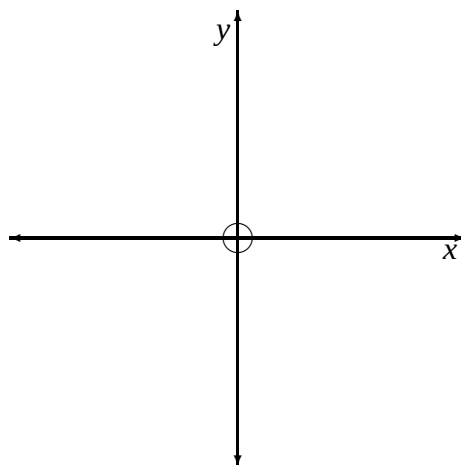
If a vertical and horizontal number line intersect perpendicularly, they form right angles (of 90°) with each other and a co-ordinate system of axes is formed. These two lines intersect to form four sections, called quadrants.



The horizontal line is called the x -axis, and the vertical line is called the y -axis. These two axes **MUST** be clearly indicated with an x and a y .

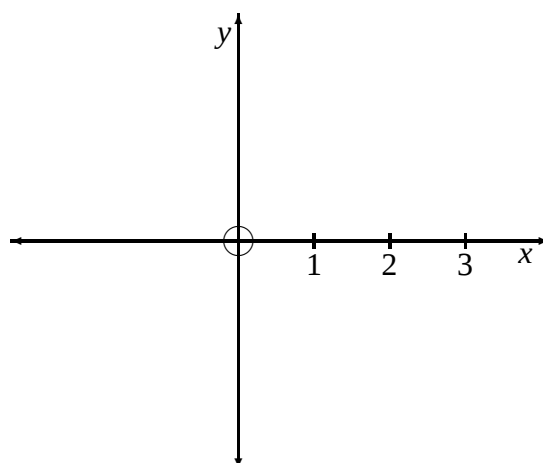


The point where the two axes intersect (cross each other) is called the *origin* and is indicated by a zero.

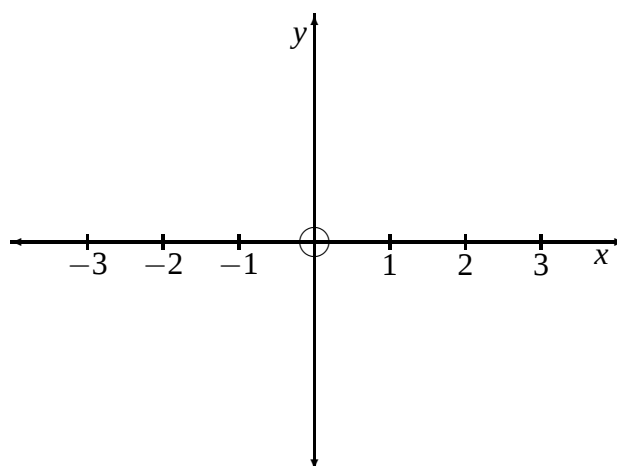


Both the x -axis (that is, the horizontal line) and the y -axis (that is, the vertical line) must be divided into sections of equal length to form a scale.

Starting from the origin and moving to the right, we divide the axis into equal parts. Note that the distance between the units (numbers) **MUST** always be the same. The numbers on the right-hand side of the origin are positive numbers.

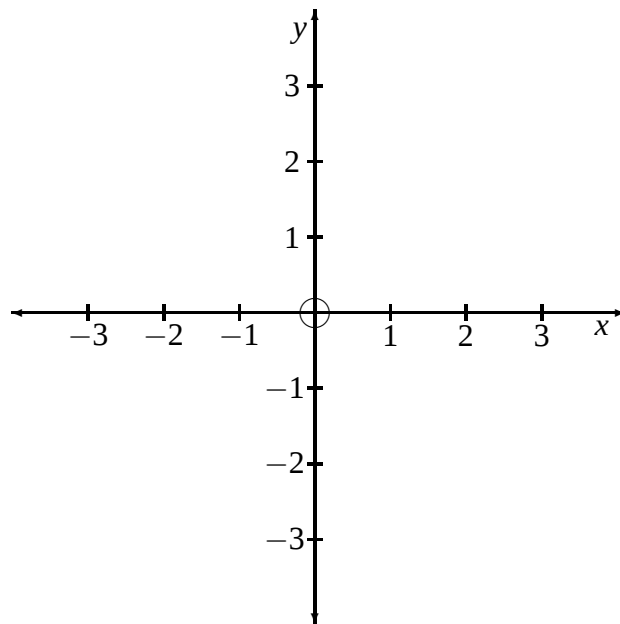


Now moving to the left of the origin, we divide the axis into units (numbers) of exactly the same length as those on the positive side. The numbers on the left-hand side of the origin are negative numbers (as is the case with the number line).



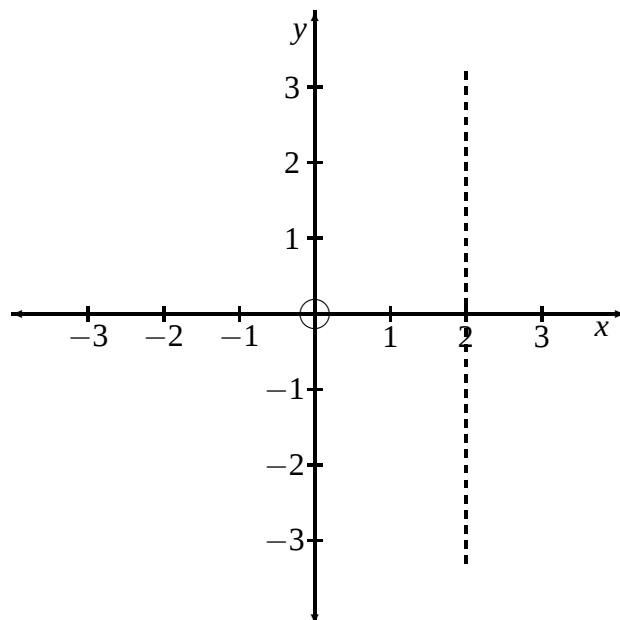
We follow the same procedure on the vertical y -axis. The numbers above the origin are positive numbers and the numbers below the origin are negative numbers.

A neat system (set) of axes is given in the following sketch.



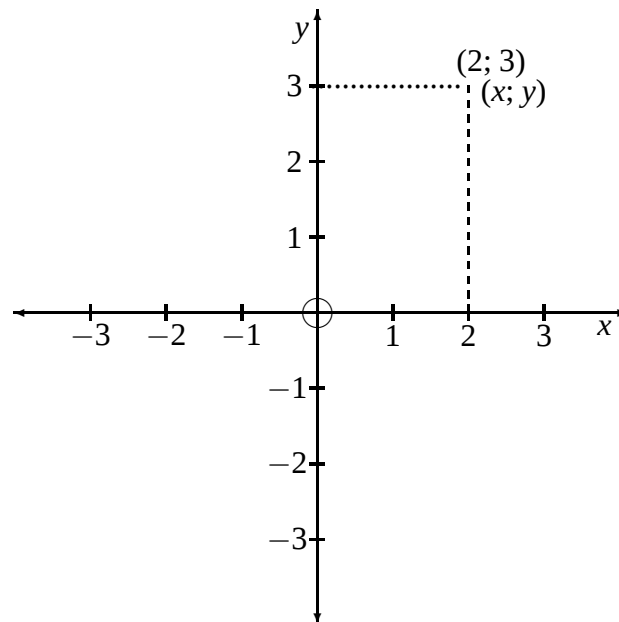
How do we use the numbers on the set of axes?

If we look at the set of axes below, we see that in any point on the broken vertical line, x is equal to 2.



A specific point is indicated by two coordinates, written as $(x; y)$.

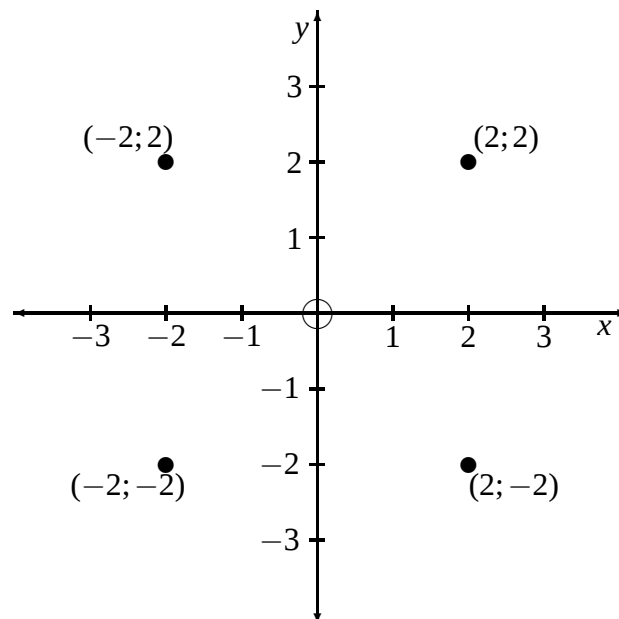
For example, to find the exact point where $(2; 3)$ lies on the system of axes, we do the following: All the points on the dotted line above have an x -coordinate of 2 and all the points on the horizontal dotted line in the following sketch has a y -coordinate of 3.



The broken line and the dotted line intersect at a point where $x = 2$ **and** $y = 3$ and we write it down as $(2; 3)$ – first the x -value and then the y -value. The order in which the numbers are written is important.

Note: On the horizontal x -axes the value of y is always **zero**. On the vertical y -axis the value of x is **always zero**.

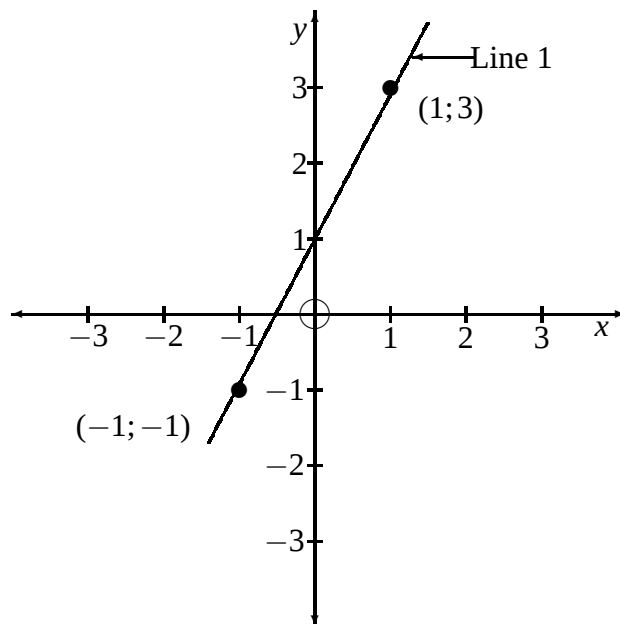
Looking at all four the quadrants, we see that in the first quadrant, both x and y are positive. In the second quadrant x is negative and y is positive. In the third quadrant the values of both x and y are negative. In the fourth quadrant y is negative and x is positive.



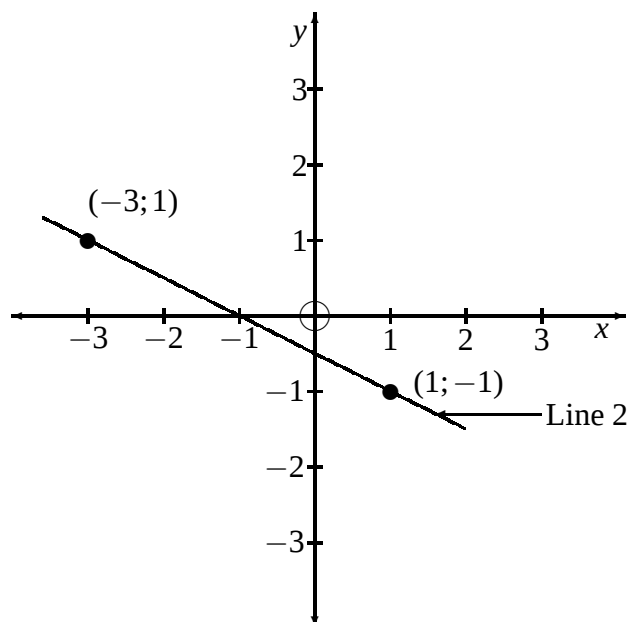
If we wish to draw a straight line (also called a graph) on a set of axes, we need two points.

Let us draw a straight line (line 1) through points $(x_1; y_1) = (1; 3)$ and $(x_2; y_2) = (-1; -1)$. We do it as follows:

1. Draw a neat set of axes and name the axes.
2. Divide the axes into equal suitable length units.
3. Plot the given points on the system of axes.
4. Join the points.
5. Name the line.

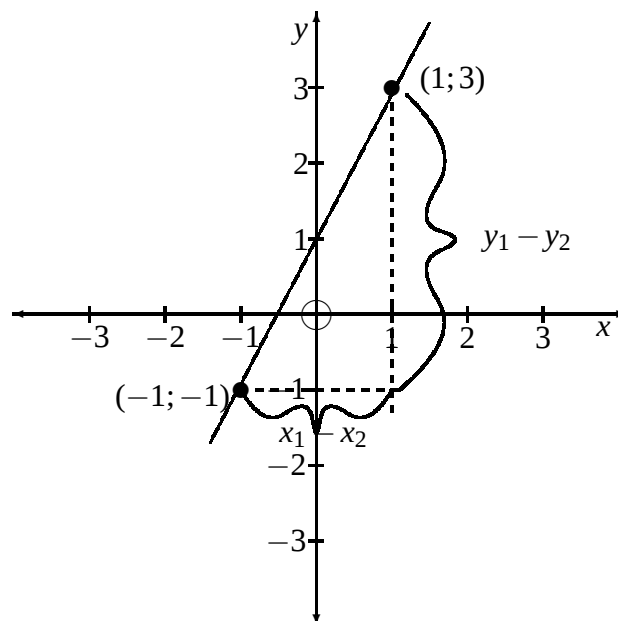


Let us draw another straight line through the points $(x_1; y_1) = (-3; 1)$ and $(x_2; y_2) = (1; -1)$ (line 2).



If we look carefully at the two graphs above we see that the first straight line (line 1) runs from the third quadrant upwards, (that is ascends from left to right) to the first quadrant. The second line (line 2) starts in the second quadrant and runs downwards (that is, descends) to the fourth quadrant. We also see that the second line is “flatter” than the first line. This “steepness” with which straight lines ascend or descend is called the *slope* or *gradient* of the line. The slope is the ratio of change in the y -value from one point to the other to the change in the corresponding x -value.

Let us look again to the line passing through the points $(1; 3)$ and $(-1; -1)$ (that is line 1).

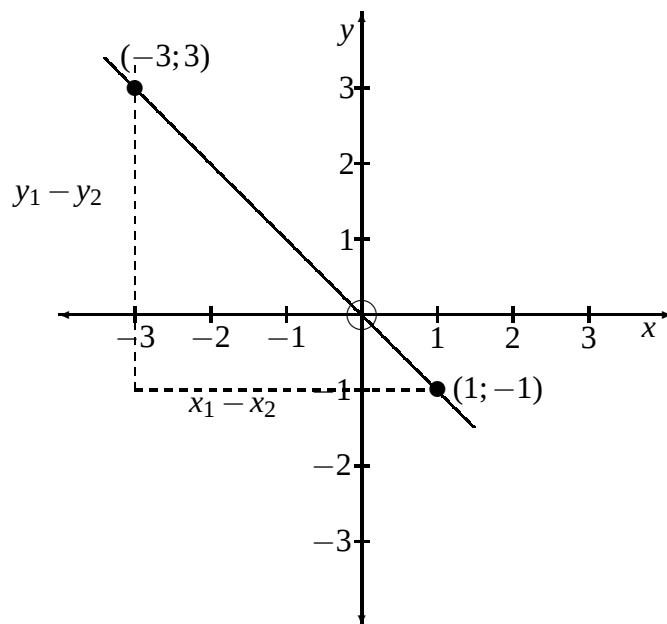


The slope of this line = $\frac{\text{change in the } y\text{-value}}{\text{change in the } x\text{-value}}$

$$\begin{aligned}
 &= \frac{y_1 - y_2}{x_1 - x_2} \\
 &= \frac{3 - (-1)}{1 - (-1)} \\
 &= \frac{4}{2} \\
 &= 2.
 \end{aligned}$$

The slope of this line is positive 2. Any straight line that runs from the third quadrant upwards (that is, ascends) from left to right has a positive slope.

Let us draw a straight line going through the points $(-3; 3)$ and $(1; -1)$.

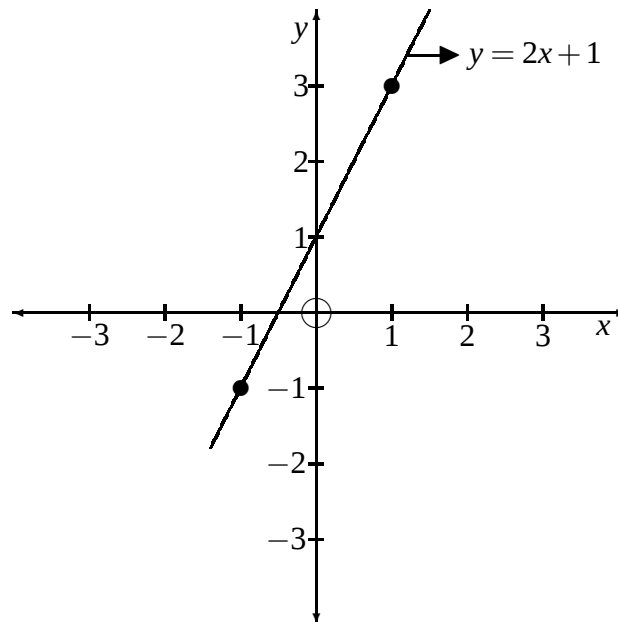


$$\begin{aligned}
 \text{The slope of this line} &= \frac{\text{change in the } y\text{-value}}{\text{change in the } x\text{-value}} \\
 &= \frac{y_1 - y_2}{x_1 - x_2} \\
 &= \frac{3 - (-1)}{-3 - (1)} \\
 &= \frac{4}{-4} \\
 &= -1.
 \end{aligned}$$

The slope of this line is negative. Any line that has a descending (that is downwards) trend from left to right has a negative slope.

Almost all straight lines intersect the y -axis.

Refer to the straight line passing through the points $(1; 3)$ and $(-1; -1)$ (line 1), again.



We have calculated that the slope of this line is 2. We see from the graph that it intersects the vertical axis, y -axis, at 1. Can this information be represented in an equation?

Yes, there is a general functional equation that we can use to represent this information.

The equation for a straight line is

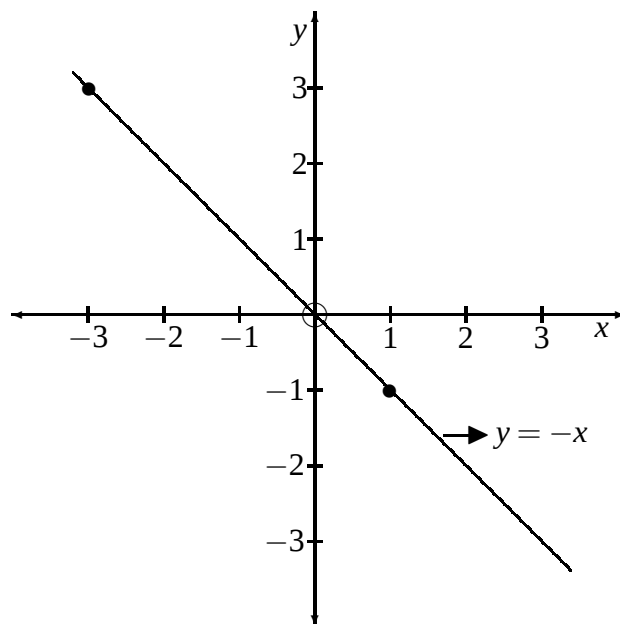
$$y = bx + a$$

where b the slope of the line and a the y -intercept.

The equation for a straight line passing through the points $(1; 3)$ and $(-1; -1)$ is given by

$$y = 2x + 1$$

Let us determine the equation for the straight line passing through points $(-3; 3)$ and $(1; -1)$ (line 3).



We have calculated that the slope of the line is -1 and looking at the graph we see that the y -intercept is zero.

The equation for this line is thus

$$\begin{aligned} y &= bx + c \\ &= -1x + 0 \\ &= -x. \end{aligned}$$

Can we determine the **equation for a straight line passing through two points** without drawing a graph? Yes, we can by using the following equation:

$$\frac{y - y_1}{x - x_1} = \frac{y_2 - y_1}{x_2 - x_1}$$



Example 6.1

1. Determine the equation for the line through the two points

$(x_1; y_1) = (1; 3)$ and $(x_2; y_2) = (-1; -1)$ and draw this line.

$$\frac{y-y_1}{x-x_1} = \frac{y_2-y_1}{x_2-x_1}$$

$$\frac{y-3}{x-1} = \frac{-1-3}{-1-1}$$

$$\frac{y-3}{x-1} = \frac{-4}{-2}$$

$$\frac{y-3}{x-1} = 2$$

$$y-3 = 2(x-1)$$

$$y-3 = 2x-2$$

$$y = 2x-2+3$$

$$y = 2x+1.$$

If one has the equation for a straight line can one then draw that line?
Yes! This is how we do it:

Draw up a table choosing three values for x – the third point is to check if your calculations are correct:

x	0	1	2
y			

Now substitute the x -values into the equation:

$$y = 2x+1$$

$$\begin{aligned} \text{If } x = 0 \text{ then } y &= 2(0)+1 \\ &= 0+1 \\ &= 1 \end{aligned}$$

$$\begin{aligned} \text{If } x = 1 \text{ then } y &= 2(1)+1 \\ &= 2+1 \\ &= 3 \end{aligned}$$

$$\begin{aligned} \text{If } x = 2 \text{ then } y &= 2(2)+1 \\ &= 4+1 \\ &= 5 \end{aligned}$$

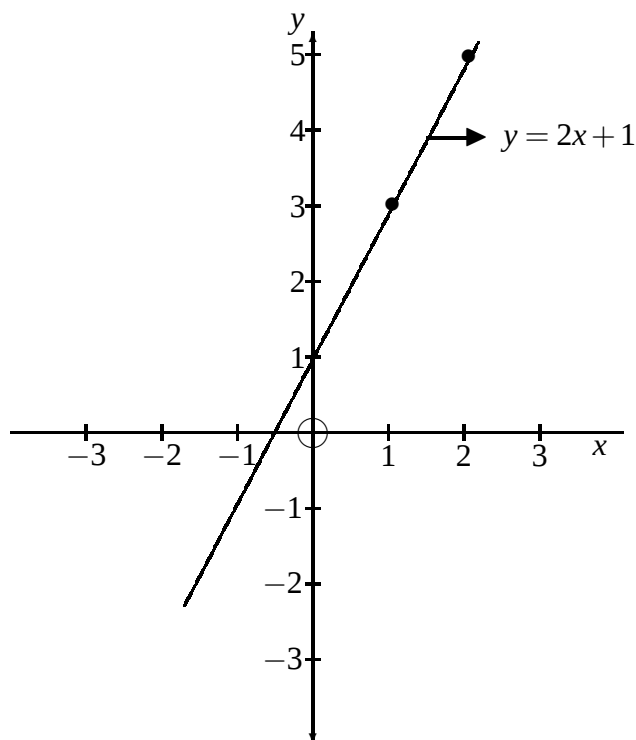
Complete the table by filling in the y values, obtained above:

x	0	1	2
y	1	3	5

This means that the points $(0; 1)$; $(1; 3)$ and $(2; 5)$ lies on the line which equation is

$$y = 2x+1.$$

Let us draw the graph by plotting the x - and the corresponding y -values (points) on the graph and join the points. We then name the graph.



2. Draw the graph of:

$$y = -x + 2$$

If $x = 0$ then $y = -(0) + 2 = 2$

If $x = 1$ then $y = -(1) + 2 = 1$

If $x = 2$ then $y = -(2) + 2 = 0$.

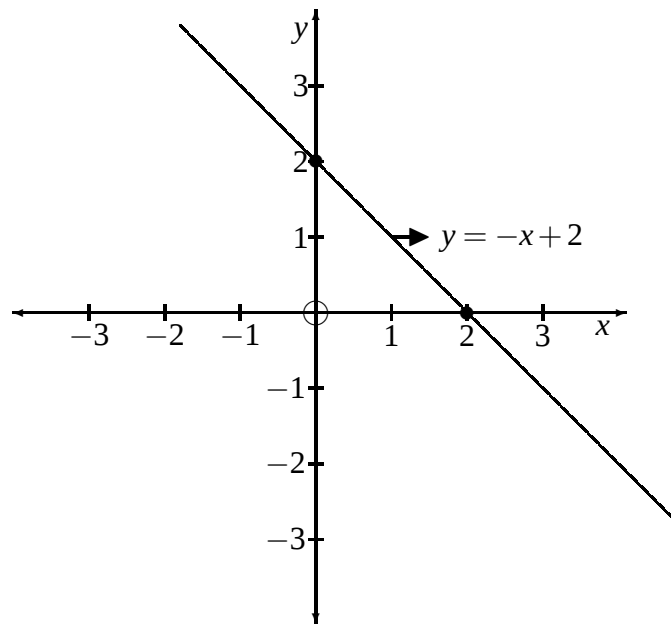
Draw up a table and fill in the y values.

x	0	1	2
y	2	1	0

The points $(0; 2)$, $(1; 1)$ and $(2; 0)$ lie on the line of

$$y = -x + 2.$$

Draw a neat set of axes, name the axes and divide them up according to a suitable scale, plot the points, join the points, and name the graph.



We can draw more than one graph on the same set of axes.

3. Draw the graphs for

(a) $y = 2x - 1$

(b) $y = -3x + 2$

(a) $y = 2x - 1$

If $x = 0$ then $y = 2(0) - 1 = -1$

If $x = 1$ then $y = 2(1) - 1 = 1$

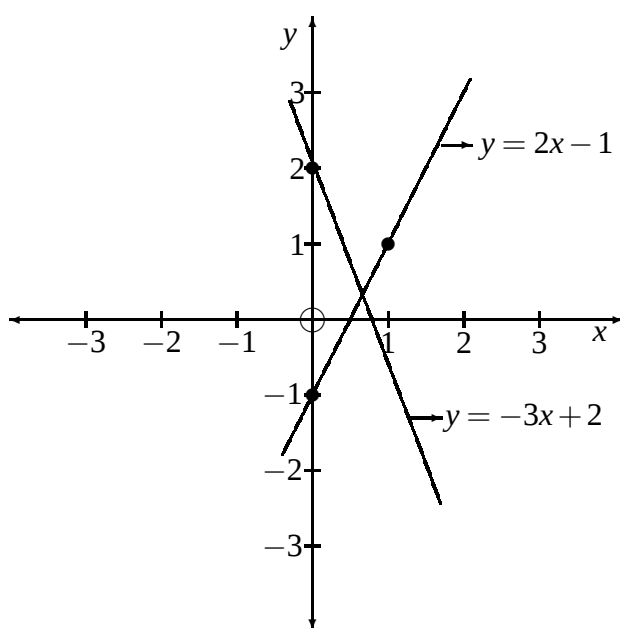

7.1 Interest

Interest is money that you receive if you have invested a sum of money, or money that you pay if you have borrowed money. The amount of interest is calculated as a fraction of the amount borrowed or saved over a period of time. The fraction, also known as the interest rate, is usually expressed as a percentage per year. The period of time should be expressed in years.

7.1.1 Simple interest

If you borrow money from the bank and the amount that you owe the bank for the loan, is calculated at the end of the time period you borrowed the money for, you pay simple interest – only one calculation is necessary.

Example 7.1

1. How much simple interest is payable on a loan of R20 000 borrowed for a period of one year at a simple interest rate of 10% per year?

The interest payable per year is 10% of R20 000:

$$\begin{aligned}\text{Interest payable} &= 10\% \times 20\,000 \\ &= \frac{10}{100} \times 20\,000 \\ &= 0,10 \times 20\,000 \\ &= 2\,000\end{aligned}$$

The above means that at the end of the year (that is after 12 months) R2 000 interest is owed to the bank.

Can we formulate an equation for calculating simple interest?

Yes! Let us try to do so:

The interest (I) payable equals the original amount borrowed, also called the principal (P) or **present value**, multiplied by the interest rate (r) per year, multiplied by the time in years (t) that we borrowed the money for.

The formula to calculate the **simple interest** is:

$$I = Prt$$

where P is the principle amount borrowed or the present value of the loan r is the simple interest rate per year and t is the time in years that the principle is borrowed. Let us use this equation and see if the above calculation was correct.

$$\begin{aligned}I &= Prt \\ &= 20\,000 \times 0,10 \times 1 \\ &= 2\,000\end{aligned}$$

Now let us set up a formula for the **future value** or accumulated amount (S) – that is the total amount payable at the end of the period of time the money is borrowed for:

$$\begin{aligned}S &= P(\text{principal}) + I(\text{interest payable}) \\ &= P + Prt \quad (\text{Replace } I \text{ with } Prt) \\ &= P(1 + rt) \quad (\text{Take out the common factor } P)\end{aligned}$$

Thus, the **future value** formula is

$$S = P(1 + rt)$$

Let us test our new formula.

$$\begin{aligned} S &= P(1 + rt) \\ &= 20\,000 \left(1 + \frac{10}{100} \times 1\right) \\ &= 20\,000 (1 + 0,10 \times 1) \\ &= 20\,000 (1 + 0,10) \\ &= 20\,000 (1,10) \\ &= 22\,000 \end{aligned}$$

See Appendix B (7.1)
for how to enter this
calculation on your
calculator

An amount of R22 000 must be paid back at the end of year one.

We could also use our calculator to do this calculation.

The answer is 22 000.

If we wish to borrow the money for a period of three years the total amount payable is

$$\begin{aligned} S &= P(1 + rt) \\ &= 20\,000 \left(1 + \frac{10}{100} \times 3\right) \\ &= 20\,000 (1 + 0,10 \times 3) \\ &= 26\,000. \end{aligned}$$

See Appendix B (7.2)

2. Martha invested R1 500 for 21 months. The applicable simple interest rate is 9% per year. Determine the amount of interest that Martha will receive in 21 months' time.

In the formula time has been defined in years, therefore, the 21 months should be written in years, and therefore divided by 12.

$$\begin{aligned} I &= Prt \\ &= 1\,500 \times \frac{9}{100} \times \frac{21}{12} \\ &= 236,25 \end{aligned}$$

Martha will receive R236,25 interest after 21 months.

3. Sera must pay Stephan an amount of R3 500 in 6 years' time. A 12,5% simple interest rate is applicable. Determine the amount that Sera borrowed from Stephan 6 years ago.

$$\begin{aligned} S &= P(1 + rt) \\ 3\,500 &= P \left(1 + \frac{12,5}{100} \times 6\right) \\ P &= \frac{3\,500}{\left(1 + \frac{12,5}{100} \times 6\right)} \\ &= 2\,000 \end{aligned}$$

Now fill in the values of the variables.

$$\begin{aligned}
 t &= \left(\frac{7500}{5000} - 1\right) \div \frac{7,5}{100} \\
 &= (1,5 - 1) \times \frac{100}{7,5} \\
 &= 0,5 \times \frac{100}{7,5} \\
 &= 6,6667.
 \end{aligned}$$

7.1.2 Compound interest

In the case of simple interest only one calculation of interest is done, namely at the end of the contract or investment period.

In the case of compound interest, interest is calculated at regular intervals, without paying or withdrawing the interest that means that interest is also calculated on interest during the following compounding periods.

Example 7.2

1. Simple interest

Suppose you invest R1 000 for three years at a simple interest rate of 10% per year. At the end of the three year period you will have earned interest, I , where

$$\begin{aligned} I &= Prt \\ &= 1\,000 \times 0,10 \times 3 \\ &= R300 \end{aligned}$$

and the accumulated amount will be $R(1\,000 + 300) = R1\,300$.

2. Compound interest

Suppose the interest is calculated at the end of each year and instead of withdrawing the interest, you leave the interest in the account. Then, after one year you will have earned

$$\begin{aligned} I &= Prt \\ &= 1\,000 \times 0,10 \times 1 \\ &= 100. \end{aligned}$$

This R100 is added to the principal and at the end of year two you will receive interest on the original principal of R1 000 plus the interest of R100 – thus on R1 100.

The interest earned in the second year is

$$\begin{aligned} I &= Prt \\ &= 1\,100 \times 0,10 \times 1 \\ &= 110. \end{aligned}$$

At the end of year two you will have a balance of

$R(1\,100 + 110) = R1\,210$ in your account.

The interest earned in the third year is

$$\begin{aligned} I &= Prt \\ &= 1\,210 \times 0,1 \times 1 \\ &= 121 \end{aligned}$$

and at the end of the third year you will have a balance of $R(1\,210 + 121) = R1\,331,00$ in your account.

As you see, if interest is calculated more frequently and not withdrawn you earn $R(1\,331 - 1\,300) = R31$ more in interest than when the calculation is done at the end of the investment time. Interest that is calculated more frequently and not withdrawn is called compound interest.

The above boils down to an interest-on-interest situation. Compound interest is just the repeated application of simple interest to the principal which at each stage is increased by the simple interest earned in the previous period.

Instead of doing a separate calculation for every compound period, we do only one calculation by using the **compound interest formula** namely:

COMPOUND INTEREST

$$S = P(1 + i)^n$$

where

S = the accumulated amount or future value

P = the principal or present value

i = the given interest rate per year divided by the number of compounding periods per year

n = the time in years multiplied by the number of compounding periods per year.

Let us use the formula to check our calculations above:

$$\begin{aligned} S &= P(1 + i)^n \\ &= 1\,000 \left(1 + \frac{10\%}{1}\right)^{3 \times 1} \\ &= 1\,000(1 + 0,10)^3 \\ &= 1\,331,0000 \end{aligned}$$

Ordinary calculator steps:

1 000 $\times$ (1 $+$ 0,10) 2ndF y^x 3 $=$

The accumulated amount after three years, if R1 000 is invested at 10% compound interest compounded annually, is R1 331,00.

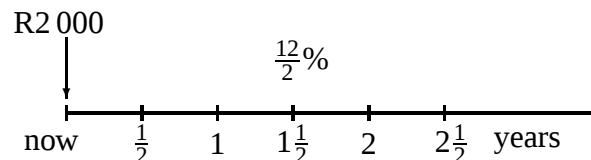

Note: The prescribed financial calculator has been pre-programmed to do these types of compound interest calculations.

See Tutorial Letter 101 for the explanation of the use of the financial keys on the calculator. It is very important to study the calculator examples in Appendix B.

The above may be represented on a time line as



By using the formula:

$$S = P(1+i)^n$$

$$\text{where } P = 2000$$

$$i = 12\% \div 2 \quad \text{The interest is compounded every six months that is twice a year } \left(\frac{12}{6} = 2\right)$$

$$n = 2,5 \times 2$$

$$S = 2000 \left(1 + \frac{12\%}{2}\right)^{2,5 \times 2}$$

$$S = 2000 \left(1 + \frac{0,12}{2}\right)^{2,5 \times 2}$$

$$= 2676,4512$$

Ordinary calculator steps:

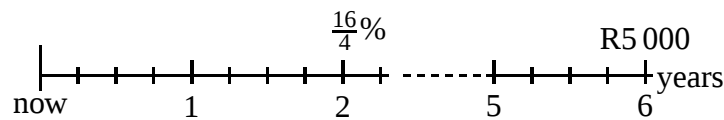

Cheryl will receive R2 676,45 after $2\frac{1}{2}$ years.

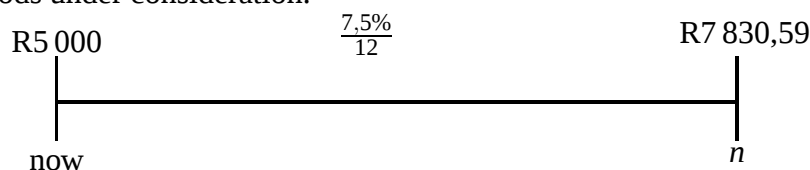

$$7\,830,59 = 5\,000 \left(1 + \frac{7,5\%}{12} \right)^n$$

$$7\,830,59 = 5\,000 \left(1 + \frac{0,075}{12} \right)^n$$

$$n = 72 \quad (\text{Logarithms have to be used})$$

Debbie invested her money for 72 months which is 6 years.

Note: One needs the knowledge of logarithms if the unknown is in the exponent. Logarithms are not part of this module's syllabus, therefore it is advised that students use the **financial keys** on the calculator in such a case. See Appendix B (7.10).

7.2 Annuities

In each of the above instances only one amount was either lent or borrowed.

In the case of simple interest only one calculation was done and the interest was added to the principal at the end of the whole period.

In the case of compound interest, only one amount was either lent or borrowed and the interest was calculated according to the number of compounding periods per year which can differ from one investment to another. After each calculation the interest was added to the principal and the interest for the following compounding period, was calculated on the new principal, and so forth.

There are also situations where the same amount of money is paid into an account at certain fixed equal time intervals. For example:

Every Monday morning you deposit R100 into a bank account without withdrawing any money from this account. Or you deposit say R1 000 into an account every 15th of a month without withdrawing any money from this account. You could also deposit the same amount every year as long as the in-

tervals between the payments are exactly the same. This type of transaction is called an annuity.

An annuity is a sequence of equal (same amount) payments at equal time intervals.

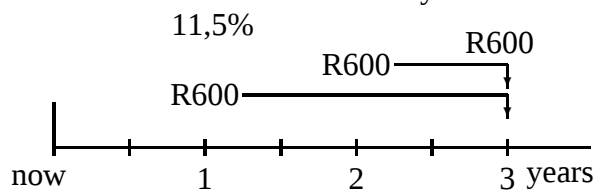
There are two types of formulas to determine different values of annuities.

7.2.1 The future value of an annuity

The **future value** of an annuity, is the balance in an account after a series of payments have been made at equal time intervals.

Example 7.3

1. Suppose Bert deposited an amount of R600 at the end of every year into an account earning 11,5% interest per year for three years. Determine the accumulated amount at the end of year three.



The first deposit will earn interest for two years, and will amount to

$$\begin{aligned}
 S &= P(1+i)^n \\
 &= 600(1+11,5\%)^2 \\
 &= 600(1+0,115)^2 \\
 &= 745,94
 \end{aligned}$$

The second deposit will earn interest for one year, and will amount to

$$\begin{aligned}
 S &= P(1+i)^n \\
 &= 600(1+11,5\%)^1 \\
 &= 600(1+0,115)^1 \\
 &= 669,00
 \end{aligned}$$

The third R600 will earn no interest.

At the end of year three Bert will have a balance of

$R(754,94 + 669,00 + 600) = R2\,014,94$ in the account.

Just think what it would be like if you had to do, say 30 of the above calculations!

Instead, the following formula may be used for determining the future value of an annuity.

The formula for **future value** of an annuity is

FUTURE VALUE

$$S = R \left(\frac{(1+i)^n - 1}{i} \right)$$

A shortened version of the formula is

$$S = Rs_{\overline{n}|i}$$

(In this shortened version of the formula, the given information is sort of summarized).

where S = the future value or accumulated amount

R = equal payments made at equal time intervals

i = the applicable interest rate divided by the number of compounding periods per year

n = time in years multiplied by the number of payments per year

$s_{\overline{n}|i}$ = in words S n angle i

where n = the number of years multiplied by the number of compounding periods per year

i = the yearly interest rate divided by the number of compounding periods

Let us use the formula above to check our previous example.

$$\begin{aligned} S &= Rs_{\overline{n}|i} \\ &= 600s_{\overline{3}|11,5\%} \\ &= 600s_{\overline{3}|0,115} \\ &= 2014,94 \end{aligned}$$

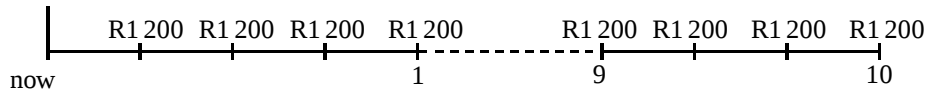

What does this mean? It means that if you deposit an amount of R600 at the end of every year into an account earning 11,5% interest per year, there will be a balance of R2 014,94 in the account after three years.

2. Determine the accumulated amount of an annuity with quarterly payments of R1 200, at an interest rate of 16% per year, compounded quarterly, made over a period of 10 years.



The values of the variables are as follows:

$$R = 1\,200$$

$$n = 10(\text{years}) \times 4 (\text{number of compounding periods})$$

$$i = 16\% \div 4 = 0,016 \div 4$$

$$\begin{aligned} S &= Rs_{\overline{n}|i} \\ &= 1\,200s_{\overline{10 \times 4}|16\% \div 4} \\ &= 1\,200s_{\overline{10 \times 4}|0,16 \div 4} \\ &= 114\,030,6188 \end{aligned}$$

The accumulated amount of R1 200 made every quarter for 10 years is R114 030,62.

7.2.2 Present value of an annuity

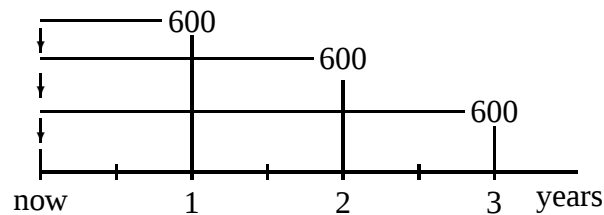
The **present value** of an annuity is the amount of money (balance) in an account *now* which have to be paid off in equal payments at equal time intervals at a set interest rate so that the balance will be zero at the end of the time period.

Example 7.4

1. Determine the **present value** of an annuity with yearly payments of R600 made at the end of each year, at an interest rate of 11,5% per year, for a term of three years.

If we do a step-by-step calculation, without a formula, we do it as follows:

The relevant time line is given below.



We wish to determine the value of the annuity *now*. We have to find the present value of each payment of R600 now.

The present value of the first R600 is P in the formula

$$\begin{aligned}
 S &= P(1+i)^n \\
 600 &= P(1+11,5\%)^1 \quad (1 \text{ year discounted}) \\
 P &= \frac{600}{(1+11,5\%)^1} \\
 P &= \frac{600}{(1+0,115)^1} \\
 &= 538,1166 \\
 &\approx 538,12
 \end{aligned}$$

The present value of the second R600 is P in the formula

$$\begin{aligned}
 S &= P(1+i)^n \\
 600 &= P(1+11,5\%)^2 \quad (2 \text{ years discounted}) \\
 P &= \frac{600}{(1+11,5\%)^2} \\
 P &= \frac{600}{(1+0,115)^2} \\
 &= 482,6158 \\
 &\approx 482,62
 \end{aligned}$$

The present value of the third R600 is P in the formula

$$\begin{aligned}
 S &= P(1+i)^n \\
 600 &= P(1+11,5\%)^3 \quad (3 \text{ years discounted}) \\
 P &= \frac{600}{(1+11,5\%)^3} \\
 P &= \frac{600}{(1+0,115)^3} \\
 &= 432,8393 \\
 &\approx 432,84
 \end{aligned}$$

The present value of the annuity is thus

$$R(538,12 + 482,62 + 432,84) = R1\,453,58.$$

We can however use the following formula to do **present value** annuities calculations:

PRESENT VALUE

$$P = R \left[\frac{(1+i)^n - 1}{i(1+i)^n} \right]$$

A shortened version of the formula is

$$P = Ra_{\overline{n}|i}$$

where P = the present value or principal

R = equal payments made at equal time interval

i = the applicable interest rate divided by the number of compounded periods per year

n = time in years multiplied by the number of payments per year

Let us use the formula to check our above example.

$$\begin{aligned}
 P &= Ra_{\overline{n}|i} \\
 &= 600a_{\overline{3}|11,5\%} \\
 &= 600a_{\overline{3}|0,115} \\
 &= 1\,453,5716
 \end{aligned}$$

Note: There is a one cent difference because we rounded three times in the step-by-step calculation and only once by using the formula.

This means that if you were to pay R600 every year for three years at an interest rate of 11,5% per year, you would be able to pay off a debt of R1 453,57.

First determine the value of the variables.

$$R = 1\,500$$

$$n = 6 \times 4, \text{ the number of years multiplied by the number of compounding periods per year}$$

$$i = 12,6 \div 4, \text{ the interest rate per year divided by the number of compounding periods per year}$$

$$\begin{aligned}
 P &= Ra_{\overline{n}|i} \\
 &= 1\,500a_{\overline{6 \times 4}|12,6\% \div 4} \\
 &= 1\,500a_{\overline{6 \times 4}|0,126 \div 4} \\
 &= 24\,997,6658
 \end{aligned}$$

7.3 Amortisation

If we buy a house we usually borrow money from the bank to pay for the house. The bank will then issue a mortgage loan that must be paid back over a period of time. A mortgage loan is said to be amortised if all the liabilities (that is the principal and interest) are paid in equal payments at equal time intervals.

Note: We use the **present value formula** to determine the monthly payment and the outstanding principal.

Example 7.5

1. A loan of R50 000 is to be amortised at an interest rate of 15% per year, compounded monthly by means of equal monthly payments over a period of ten year years. The first payment is due at the end of the first month. Determine the monthly payment.

$$\begin{aligned}
 P &= Ra_{\overline{n}|i} \\
 50\,000 &= Ra_{\overline{10 \times 12}|15\% \div 12} \\
 R &= \frac{50\,000}{a_{\overline{10 \times 12}|15\% \div 12}} \\
 R &= \frac{50\,000}{a_{\overline{10 \times 12}|0,15 \div 12}} \\
 &= 806,6748
 \end{aligned}$$

By using the financial keys on the calculator:

The monthly payment is R806,67.

Note: There is an extra amount that must be paid when a loan is amortised. The monthly payment includes the interest on the outstanding balance in the account. This may best be understood by drawing up an amortization schedule (table).

2. A loan of R5 000 is to be repaid at an interest rate of 15% per year over a five year period.

A step-by-step calculation follows:

The **yearly payments** are:

$$\begin{aligned}
 P &= Ra_{\overline{n}|i} \\
 5000 &= Ra_{\overline{5}|15\%} \\
 5000 &= Ra_{\overline{5}|0,15} \\
 R &= 1491,58 \quad (\text{by using the financial calculator keys})
 \end{aligned}$$

See Appendix B (7.21)

At the end of year one the interest due is:

$$\begin{aligned}
 I &= Prt \\
 &= 5000 \times 15\% \times 1 \\
 &= 5000 \times 0,15 \times 1 \\
 &= 750,00.
 \end{aligned}$$

This amount must be subtracted from the payment of R1 491,58 to have the amount of capital paid off with this payment. Thus, an amount of only $R(1491,58 - 750) = R741,58$ was repaid.

The outstanding balance at the beginning of year two is thus $R(5000 - 741,58) = R4258,42$.

Note: Before the total yearly payment can be deducted from the outstanding balance, 15% interest is to be paid on the above amount:

$$\text{Interest due} = 4258,42 \times 15\% = 638,76$$

Therefore, the actual amount that can be deducted from the loan is $R(1491,58 - 638,76) = R852,82$. The outstanding principal at the beginning of year three is thus $R(4258,42 - 852,82) = R3405,60$.

The interest due is $15\% \times 3405,60 = R510,84$. The loan is therefore reduced by an amount of $R(1491,58 - 510,84) = R980,74$. The outstanding amount at the beginning of year four is $R(3405,60 - 980,74) = R2424,86$.

The interest due is 15% of R2 424,86 = R363,73 while the amount with which the loan is reduced is $R(1\,491,58 - 363,73) = R1\,127,85$. The outstanding balance at the beginning of year five is $R(2\,424,86 - 1\,127,85) = R1\,297,01$.

The interest of 15% of R1 297,01 amounts to R194,55. If we deduct this amount from the yearly payment of R1 491,58 it becomes R1 297,03 which is 2 cent more than the outstanding principal at the beginning of year five. This is due to rounding errors.

The above information may be represented in a amortisation schedule as follows:

For example, to determine the outstanding balance at the beginning of year four, we do the following:

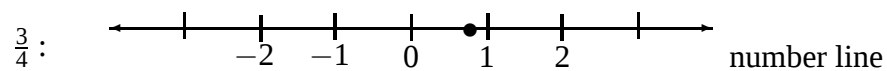
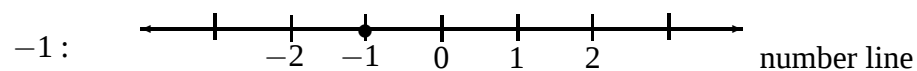

246 cm is equal to 0,00246 km

Given: A circle with $r = 4,5$ m.

The circumference is calculated as

$$\begin{aligned} C &= 2\pi r \\ &= 2 \times \pi \times 4,5 \\ &\approx 28,27 \end{aligned}$$

The **circumference of the circle** is 28,27 m.

Exercise 4.2:1(e)

Given: A figure with four sides of length 12 m, 35 m, 7 m, and 13 m.

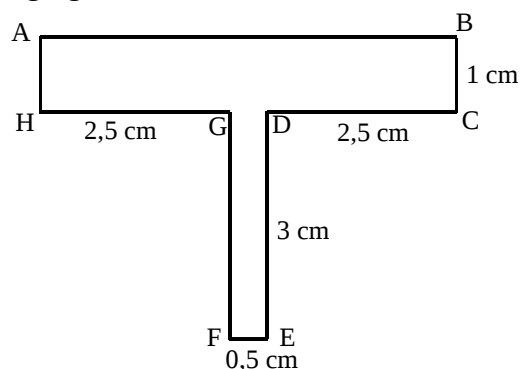
The perimeter is calculated as

$$\begin{aligned} C &= 12 + 35 + 7 + 13 \\ &= 67 \end{aligned}$$

The perimeter of the figure is 67 m.

Exercise 4.2:2

Given: The following figure:



We see that the length of AB is equal to the sum of the lengths of CD, EF and GH. Therefore

$$\begin{aligned} \text{Length of AB} &= \text{Length of CD} + \text{Length of EF} + \text{Length of GH} \\ &= 2,5 + 0,5 + 2,5 \\ &= 5,5 \end{aligned}$$

The length of AB is thus 5,5 cm.

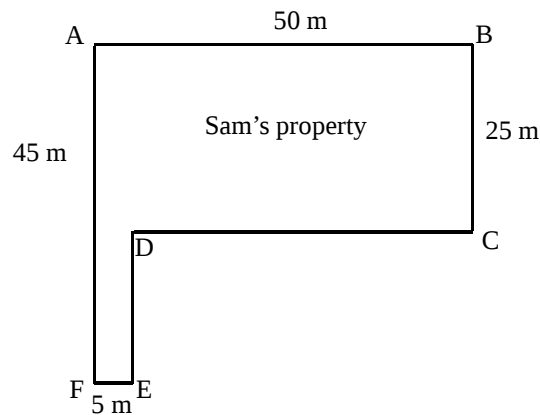
The perimeter is calculated as

$$\begin{aligned} C &= AB + BC + CD + DE + EF + FG + GH + HA \\ &= 5,5 + 1 + 2,5 + 3 + 0,5 + 3 + 2,5 + 1 \\ &= 19 \end{aligned}$$

The perimeter of the figure is 19 cm.

Exercise 4.2:3

Given: The following figure:



First calculate the lengths of CD and DE:

$$\begin{aligned} \text{Length of CD} &= \text{Length of AB} - \text{Length of EF} \\ &= 50 - 5 \\ &= 45 \end{aligned}$$

The length of CD is 45 m.

$$\begin{aligned} \text{Length of DE} &= \text{Length of AF} - \text{Length of BC} \\ &= 45 - 25 \\ &= 20 \end{aligned}$$

The length of DE is 20 m.

The perimeter is calculated as

$$\begin{aligned} C &= AB + BC + CD + DE + EF + FA \\ &= 50 + 25 + 45 + 20 + 5 + 45 \\ &= 190. \end{aligned}$$

Sam needs 190 m of fencing.

Exercise 4.3:1

We know that $1000\text{ m} = 1\text{ km}$ and $1\text{ ha} = 100\text{ m} \times 100\text{ m} = 10\,000\text{ m}^2$.

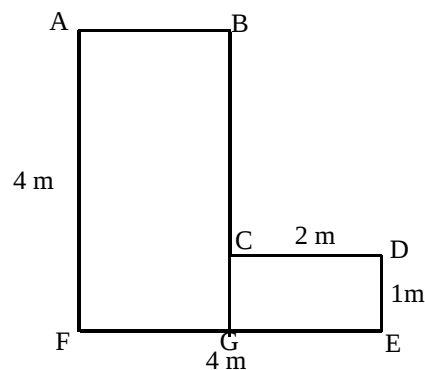

The length of AB is 2 m.

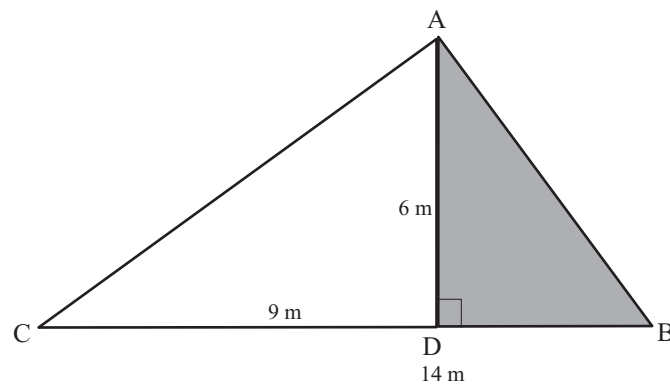

 A &= \text{area ABGF} + \text{area CDEG} \\
 &= (AB \times BG) + (CD \times DE) \\
 &= (2 \times 4) + (2 \times 1) \\
 &= 8 + 2 \\
 &= 10.
 \end{aligned}$$

The area of the figure is 10 m^2 .

Exercise 4.4:1

Given: The following figure:



Calculate the length of BD.

$$\begin{aligned}
 \text{Length of BD} &= \text{Length of BC} - \text{Length of CD} \\
 &= 14 - 9 \\
 &= 5
 \end{aligned}$$

The length of BD is 5m.

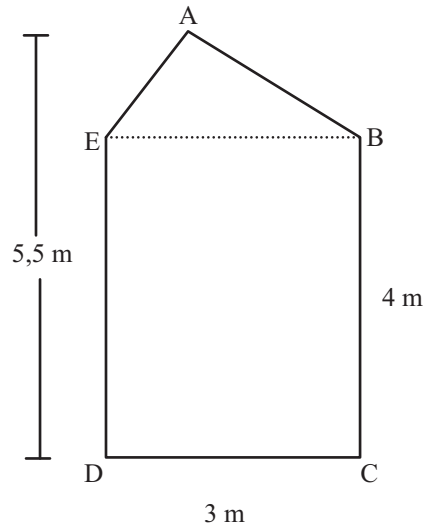
The area is calculated as:

$$\begin{aligned}
 A &= \text{area ABD} \\
 &= \frac{1}{2}bh \\
 &= \frac{1}{2}BD \times AD \\
 &= \frac{1}{2} \times 5 \times 6 \\
 &= 15.
 \end{aligned}$$

The area of the shaded figure is 15 m^2 .

Exercise 4.4:2

Given: The following figure:



The area is a composite area of one rectangle and one triangle.

First calculate the perpendicular height of the triangle ABE:

$$\begin{aligned}
 h &= \text{Total height} - \text{Length of BC} \\
 &= 5,5 - 4 \\
 &= 1,5
 \end{aligned}$$

The perpendicular height of the triangle is 1,5 m.

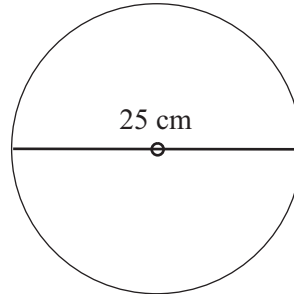
The area is calculated as

$$\begin{aligned}
 A &= \text{area ABE} + \text{area BCDE} \\
 &= \frac{1}{2}bh + (l \times w) \\
 &= \frac{1}{2}BE \times h + (BC \times CD) \\
 &= \left(\frac{1}{2} \times 3 \times 1,5\right) + (4 \times 3) \\
 &= 2,25 + 12 \\
 &= 14,25.
 \end{aligned}$$

The total area of the figure is 14,25 m².

Exercise 4.5:1

Given: The following figure:



The diameter of the circle is given as 25 cm. Therefore, the radius is

$$\begin{aligned} r &= d \div 2 \\ &= 25 \div 2 \\ &= 12,5. \end{aligned}$$

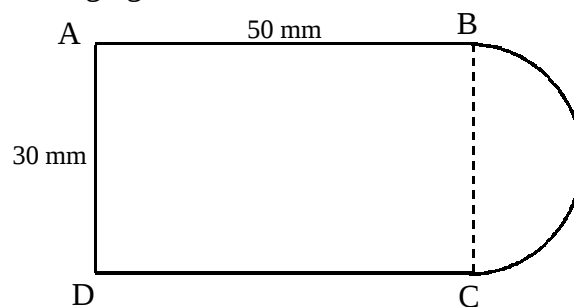
The area is calculated as

$$\begin{aligned} A &= \pi r^2 \\ &= \pi (12,5)^2 \\ &= \pi \times 156,25 \\ &\approx 490,87. \quad (\text{by using the calculator.}) \end{aligned}$$

The area of the circle is 490,87 cm².

Exercise 4.5:2

Given: The following figure:



The area is a composite area of one rectangle and one half circle, also called a semi-circle.

First calculate the radius of the half circle:

$$\begin{aligned} r &= d \div 2 \\ &= 30 \div 2 \\ &= 15 \end{aligned}$$

The radius of the half circle is thus 15 mm.

The area of the figure is calculated as:

$$\begin{aligned}
 A &= \text{area ABCD} + \text{area of half circle} \\
 &= (l \times w) + \frac{1}{2}\pi r^2 \\
 &= (AB \times AD) + \frac{1}{2}(\pi r^2) \\
 &= (50 \times 30) + \frac{1}{2}(\pi \times (15)^2) \\
 &= 1500 + 353,43 \\
 &= 1853,4292
 \end{aligned}$$

The total area of the figure is $1853,43 \text{ mm}^2$.

Exercise 4.6:1

We know that there are 1000 cm^3 in one litre.

Therefore, in half a litre we have $(1000 \div 2) = 500 \text{ cm}^3$.

Exercise 4.6:2

The dam is in a form of a cylinder with diameter 5 m and perpendicular height of 1,5 m. The volume is calculated as

$$\begin{aligned}
 V &= \pi r^2 h \\
 &= \pi \times (5 \div 2)^2 \times 1,5 \\
 &= \pi \times 9,375 \\
 &\approx 29,4524
 \end{aligned}$$

The volume of the dam is $29,452 \text{ m}^3$.

We know that $1 \text{ m}^3 = 1000 \text{ litres}$.

Therefore, the volume of the dam is $(29.452 \times 1000) \ell = 29452 \ell$.

Exercise 4.6:3

Given: A prism of size $12 \text{ cm} \times 9 \text{ cm} \times 4 \text{ cm}$.

The volume is calculated as:

$$\begin{aligned}
 V &= l \times b \times h \\
 &= 12 \times 9 \times 4 \\
 &= 432
 \end{aligned}$$

The volume of the prism is 432 cm^3 .

Exercise 4.7:1

The total area of the walls is a composite of **four** rectangles, two sets of two equal sized rectangles. We can calculate it as:

$$\begin{aligned}
 A &= 2(l \times h) + 2(b \times h) \\
 &= 2(4,3 \times 2,5\text{m}) + 2(3,4 \times 2,5) \\
 &= 21,5 + 17 \\
 &= 38,5
 \end{aligned}$$

The total area of the walls is $38,5\text{m}^2$.

Each roll of wallpaper covers $4,5\text{m}^2$.

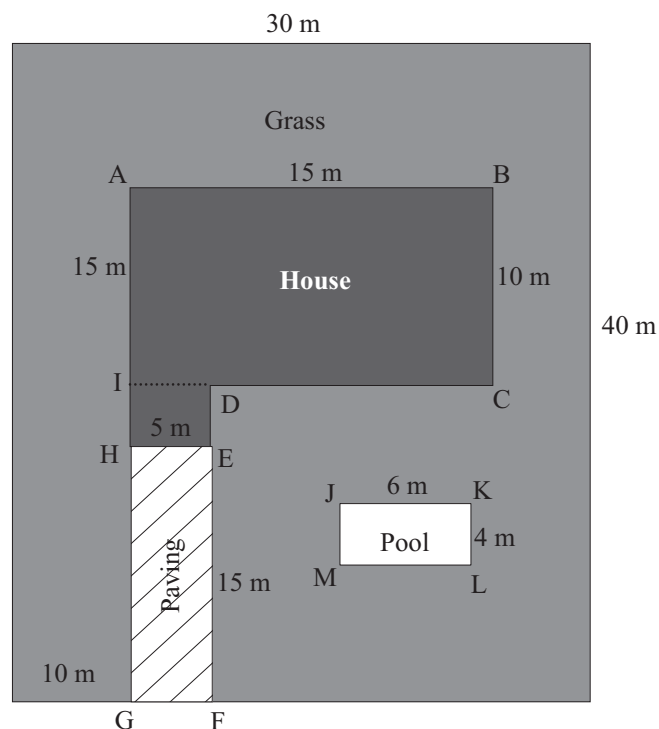
Therefore, the number of rolls needed is:

$$\begin{aligned}
 \text{Number of rolls} &= \frac{38,5}{4,5} \\
 &= 8,56
 \end{aligned}$$

The number of wallpaper rolls needed is 8,56 but as we can buy only whole rolls we round it off to 9 rolls.

Exercise 4.7:2

The area to be covered with grass must be calculated. The easiest is to calculate the area of the stand and then subtract the area of the house, paving and pool.



The area of the stand is:

$$\begin{aligned} A &= l \times w \\ &= 40 \times 30 \\ &= 1\,200 \end{aligned}$$

The area of the stand is $1\,200\text{m}^2$.

The area of the house is area ABCI plus area DEHI.

$$\begin{aligned} \text{Area ABCI} &= AB \times BC & BC &= AI = 10 \\ &= 15 \times 10 \\ &= 150 \end{aligned}$$

$$\begin{aligned} \text{Area DEHI} &= DE \times HE & DE &= AH - AI \\ &= 5 \times 5 & &= 15 - 10 \\ &= 25 & &= 5 \\ &= 25 \end{aligned}$$

$$\begin{aligned} \text{The area of the house} &= \text{ABCI} + \text{DEHI} \\ &= 150 + 25 \\ &= 175 \end{aligned}$$

The area of the house is 175m^2 .

$$\begin{aligned} \text{The area of the pool} &= \text{area of JKLM} \\ &= 6 \times 4 \\ &= 24 \end{aligned}$$

The area of the pool is thus 24m^2 .

$$\begin{aligned} \text{The area of the paving} &= \text{area of EFGH} \\ &= 15 \times 5 \\ &= 75 \end{aligned}$$

The area of the paving is thus 75m^2 .

$$\begin{aligned} &\text{The total area that has to be planted with grass} \\ &= \text{area of stand} - \text{area of house} - \text{area of pool} - \text{area of paving} \\ &= 1\,200 - 175 - 24 - 75 \\ &= 926 \end{aligned}$$

The total area that has to be planted with grass is thus 926m^2 .

$$\begin{aligned}\text{The cost to plant with kikuyu grass} &= 15 \times 926 \\ &= 13890\end{aligned}$$

It will cost you R13 890 to plant 926m^2 of kikuyu grass.

$$\begin{aligned}\text{The cost to plant with LM grass} &= 20 \times 926 \\ &= 18520\end{aligned}$$

It will cost you R18 520 to plant 926m^2 of LM grass.

Your budget allows you to spend R15 000, therefore kikuyu grass will be your choice.

Chapter 5. Equations and formulas

Exercise 5.1(a)

To solve for x subtract 4 on both sides and simplify:

$$\begin{aligned}x + 4 &= 12 \\ x + 4 - 4 &= 12 - 4 \\ x &= 8.\end{aligned}$$

The value of x is 8.

Exercise 5.1(b)

To solve for x subtract 6 on both sides and simplify:

$$\begin{aligned}6 + x &= 2 \\ 6 + x - 6 &= 2 - 6 \\ x &= -4\end{aligned}$$

The value of x is -4 .

Exercise 5.1(c)

To solve for x add 7 on both sides and simplify:

$$\begin{aligned}x - 7 &= -3 \\ x - 7 + 7 &= -3 + 7 \\ x &= 4\end{aligned}$$

The value of x is 4.

Exercise 5.1(d)

To solve for x divide by 5 on both sides and simplify

$$\begin{aligned} 5x &= 23 \\ \frac{5x}{5} &= \frac{23}{5} \\ x &= 4\frac{3}{5} \\ x &= 4,6 \end{aligned}$$

The value of x is 4,6.

Exercise 5.1(e)

To solve for x multiply with 4 on both sides and simplify

$$\begin{aligned} \frac{x}{4} &= 10 \\ \frac{x}{4} \times 4 &= 10 \times 4 \\ x &= 40 \end{aligned}$$

The value of x is 40.

Exercise 5.2(a)

To solve for x remove the number *furthest* from the x first and simplify:

$$\begin{aligned} 2x + 3 &= 6 \\ 2x + 3 - 3 &= 6 - 3 \\ 2x &= 3 \\ \frac{2x}{2} &= \frac{3}{2} \\ x &= \frac{3}{2} \end{aligned}$$

The value of x is 5.

Check your answer:

$$\begin{aligned} \text{RHS} &= 6 \\ \text{LHS : } 2\left(\frac{3}{2}\right) + 3 &= \frac{2}{1} \times \frac{3}{2} + 3 \\ &= 3 + 3 \\ &= 6 \end{aligned}$$

The RHS is equal to the LHS, therefore the answer of $\frac{3}{2}$ is correct.

Exercise 5.2(b)

Remove -4 which is the furthest from x by adding 4 on both sides and simplify:

$$\begin{aligned} 6x - 4 &= 26 \\ 6x - 4 + 4 &= 26 + 4 \\ 6x &= 30 \end{aligned}$$

Divide by 6 on both sides and simplify:

$$\begin{aligned} \frac{6x}{6} &= \frac{30}{6} \\ x &= 5 \end{aligned}$$

The value of x is 5.

Check the answer:

$$\begin{aligned} \text{RHS} &= 26 \\ \text{LHS} &= 6x - 4 \\ &= 6(5) - 4 \\ &= 30 - 4 \\ &= 26 \end{aligned}$$

The RHS is equal to the LHS, therefore the answer of 5 is correct.

Exercise 5.2(c)

To solve for x : subtract 4 on both sides, simplify, divide by 5 on both sides and simplify.

$$\begin{aligned} -5x + 4 &= 19 \\ -5x + 4 - 4 &= 19 - 4 \\ -5x &= 15 \\ \frac{-5x}{5} &= \frac{15}{5} \\ -x &= 3 \\ x &= -3. \quad (\text{Multiply or divide both sides by } -1.) \end{aligned}$$

Check the answer:

$$\begin{aligned} \text{RHS} &= 19 \\ \text{LHS} &= -5x + 4 \\ &= -5(-3) + 4 \\ &= 15 + 4 \\ &= 19 \end{aligned}$$

The RHS is equal to the LHS, therefore the answer of -3 is correct.

Exercise 5.2(d)

Add 2 on both sides, simplify, multiply by 7 on both sides and simplify to solve for x :

$$\begin{aligned}\frac{x}{7} - 2 &= 9 \\ \frac{x}{7} - 2 + 2 &= 9 + 2 \\ \frac{x}{7} &= 11 \\ \frac{x}{7} \times \frac{7}{1} &= 11 \times 7 \\ x &= 77\end{aligned}$$

Check the answer:

$$\begin{aligned}\text{RHS} &= 9 \\ \text{LHS} &= \frac{x}{7} - 2 \\ &= \frac{77}{7} - 2 \\ &= 11 - 2 \\ &= 9\end{aligned}$$

The RHS is equal to the LHS, therefore the answer of 77 is correct.

Exercise 5.3(a)

$$5(3 - x) = 4(5 + 5x)$$

Remove the brackets by multiplying 4 with both terms inside the bracket, to get

$$15 - 5x = 20 + 20x.$$

Subtract 15 on both sides of the equation

$$15 - 15 - 5x = 20 - 15 + 20x.$$

Simplify to get

$$-5x = 5 + 20x.$$

Subtract $20x$ on both sides of the equation and simplify

$$\begin{aligned}-5x - 20x &= 5 + 20x - 20x \\ -25x &= 5.\end{aligned}$$

Divide by -25 on both sides and simplify

$$\begin{aligned}\frac{-25x}{-25} &= \frac{5}{-25} \\ x &= -\frac{1}{5} \\ x &= -0,2.\end{aligned}$$

The value of $x = -0,2$ or $-\frac{1}{5}$.

Exercise 5.3(b)

$$6a + 3 + 1 = 4a - 8 - 3a$$

Add the like terms on both sides.

$$6a + 4 = a - 8$$

Subtract 4 on both sides and simplify.

$$6a + 4 - 4 = a - 8 - 4$$

$$6a = a - 12$$

Subtract a on both sides and simplify.

$$6a - a = a - a - 12$$

$$5a = -12$$

Divide by 5 on both sides and simplify.

$$\begin{aligned}\frac{5a}{5} &= -\frac{12}{5} \\ a &= -\frac{12}{5}.\end{aligned}$$

The value of a is $-\frac{12}{5}$ or $-2,4$.

Exercise 5.3(c)

$$5x + 1 - 2x = 9 - x - 4$$

Simplify the like terms on both sides.

$$3x + 1 = 5 - x$$

Subtract 1 on both sides and simplify.

$$3x + 1 - 1 = 5 - 1 - x$$

$$3x = 4 - x$$

Add x on both sides and simplify.

$$3x + x = 4 - x + x$$

$$4x = 4$$

$$x = 1.$$

The value of x is 1.

Exercise 5.3(d)

$$5x - 3(x - (3x - 4)) = 2(5x - 3(1 - 2x)) + 5$$

Remove the inner brackets first and simplify.

$$5x - 3(x - 3x + 4) = 2(5x - 3 + 6x) + 5$$

$$5x - 3x + 9x - 12 = 10x - 6 + 12x + 5$$

$$11x - 12 = 22x - 1$$

Add 12 on both sides and simplify.

$$11x - 12 + 12 = 22x - 1 + 12$$

$$11x = 22x + 11$$

Subtract $22x$ on both sides and simplify.

$$11x - 22x = 22x - 22x + 11$$

$$-11x = 11$$

$$x = -1.$$

The value of x is -1 .

Exercise 5.4

(a) $\sqrt{xy} - z = w$

To change the subject to y , we first add z on both sides of the equation and simplify.

$$\sqrt{xy} - z + z = w + z$$

$$\sqrt{xy} = w + z$$

To eliminate the $\sqrt{}$ we square both sides and simplify.

$$(\sqrt{xy})^2 = (w + z)^2$$

$$xy = (w + z)^2$$

Divide by x on both sides.

$$y = \frac{(w + z)^2}{x}. \quad \text{Note that } (w + z)^2 \neq w^2 + z^2$$

(b) $q = \frac{4r}{t^2}$

To change the subject to t , we start by getting rid of the fraction.

We multiply by t^2 on both sides and simplify.

$$q \times t^2 = \frac{4r}{t^2} \times t^2$$

$$qt^2 = 4r$$

To get t alone on the left, we divide by q on both sides and simplify.

$$\frac{qt^2}{q} = \frac{4r}{q}$$

$$t^2 = \frac{4r}{q}$$

To eliminate the power, we take the square root on both sides and simplify.

$$\begin{aligned}\sqrt{t^2} &= \sqrt{\frac{4r}{q}} \\ t &= \sqrt{\frac{4r}{q}}.\end{aligned}$$

$$(c) \quad \ell = (mk)^2$$

To change the subject to k , we first get rid of the square on the right, by taking the square root on both sides of the equation.

$$\sqrt{\ell} = mk$$

We switch the left-hand and right hand sides around, to have k on the left hand side.

$$mk = \sqrt{\ell}$$

Then we divide both sides by m .

$$\begin{aligned}\frac{mk}{m} &= \frac{\sqrt{\ell}}{m} \\ k &= \frac{\sqrt{\ell}}{m}.\end{aligned}$$

$$(d) \quad r^2 = x^2 + y^2$$

To change the subject to r , we take the square root on both sides.

$$r = \sqrt{x^2 + y^2}.$$

$$(e) \quad r^2 = x^2 + y^2$$

To change the subject to x , we switch the left and right hand sides around.

$$x^2 + y^2 = r^2$$

Then we subtract y^2 on both sides.

$$x^2 = r^2 - y^2$$

Then we take the square root on both sides to make x the subject.

$$x = \sqrt{r^2 - y^2}$$

- (f) **Note:** The formulas in (f) and (g) are the formulas used in simple interest calculations, where I is the interest, P the principal amount invested or paid, r the interest rate and t the time period.

$$I = Prt$$

To change the subject to r , we switch the left and right hand sides around.

$$Prt = I$$

Then we divide by Pt on both sides and simplify.

$$\begin{aligned}\frac{Prt}{Pt} &= \frac{I}{Pt} \\ r &= \frac{I}{Pt}\end{aligned}$$

(g) $S = P(1 + rt)$

To change the subject to t , we first remove the brackets on the right, by multiplying P with both terms inside the bracket.

$$S = P + Prt$$

Then we subtract P on both sides, simplify and switch the left and right hand sides around.

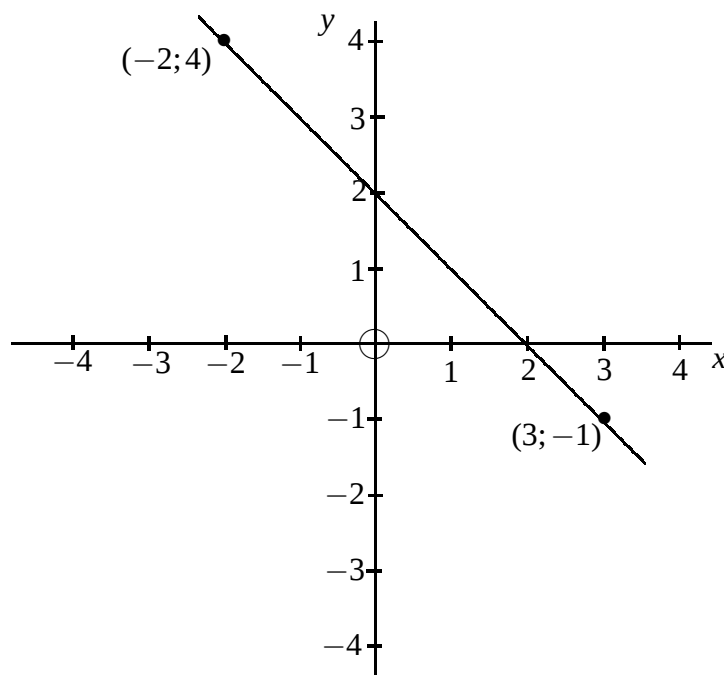

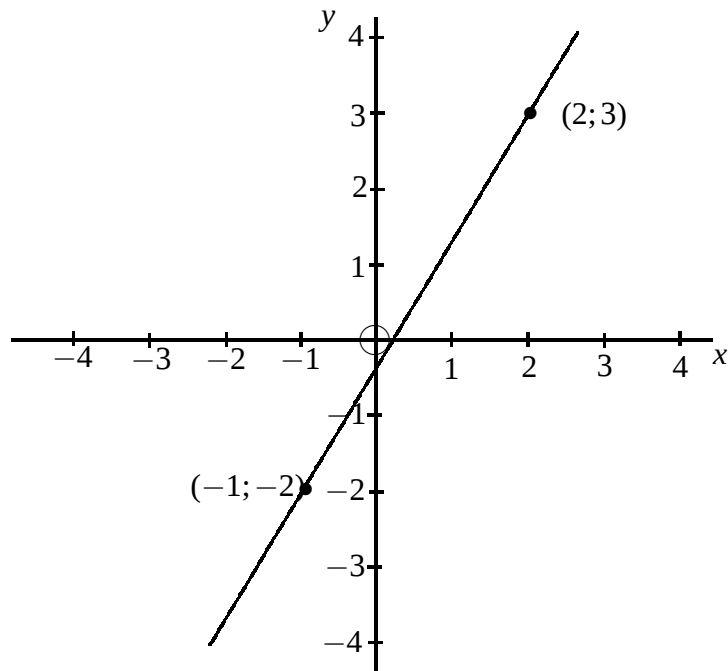

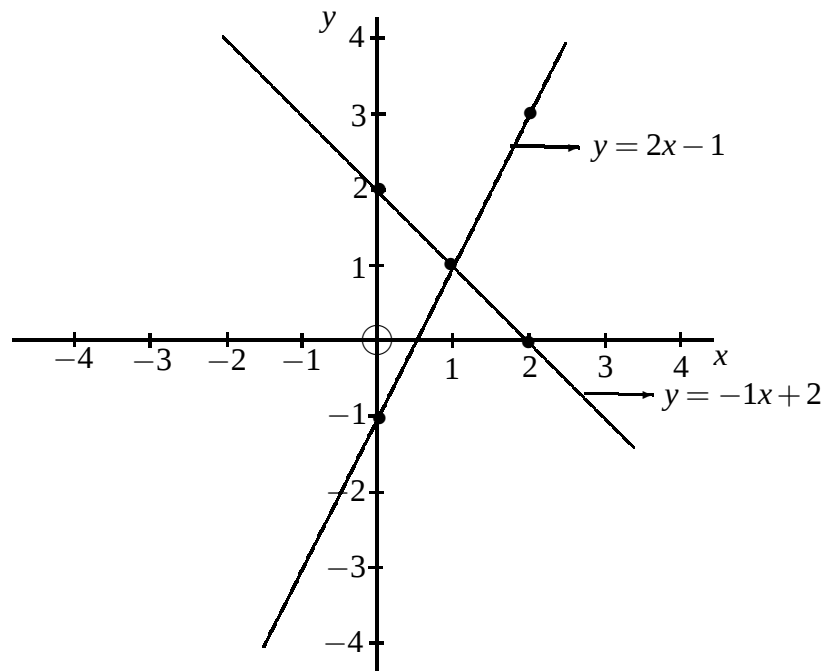
