Ms Gibson (Chairperson)

Mr Baloyi

I agree We should rather do the thing properly We predict that our organisation will continue to grow, and it would be much smarter to get out of this dump. The electrical and plumbing systems need to be redone, and a lot of costly renovation in addition to mowing the so-called lawn.

And the other option?

Mr Moloto

We have identified a property just 2.5 km from here that has lots of potential, and that would surely meet our needs for decades. It's up for grabs at R17m. We might get about R9m for this place. We'd have to move fast – that place won't stay on the market forever.

How about commissioning a feasibility study? I mean, let's rope in a consultant to investigate this option quickly and thoroughly, with detailed estimates of relocation costs. Also to make sure that the new place would meet our needs. What do you think?
