1. Personal

Prof Rassie Malherbe was born on 21 November 1952 (the same day as his wife, Marietjie), and grew up in the Western Cape. He is a family man and he and his wife, a former pre-primary school teacher, have been married for almost 35 years and have three

children and two grandchildren. He is keenly interested in religion, world affairs and history and reads widely on those and other topics. He and his wife are the co-authors of two books on dating and marriage from a biblical perspective.

2. Qualifications

Prof Malherbe finished high school in 1970 and obtained the BA, LLB degrees from the University of Stellenbosch in 1975. In 1992, he obtained his LLD degree from the Rand Afrikaans University in Johannesburg with a doctoral thesis on the legislative procedures of Parliament. He is an advocate of the Supreme Court of South Africa.

3. Career

Before entering the academic profession, Prof Malherbe was employed in public service. From 1980 to 1990 he served as a constitutional planner in which capacity he acquired extensive knowledge and experience of constitutional engineering and lectured widely at universities and other institutions on this topic. He also acquired considerable practical knowledge and skills in legislative drafting. He travelled abroad on a number of occasions for research on constitutional systems and in 1988 conducted an extensive tour of Britain, Belgium, Switzerland and the United States of America for the purposes of studying different constitutional systems. During the same year he was appointed Chief Director of Constitutional Planning in which capacity he was responsible for advice to government on alternative constitutional models for a changing South Africa.

In July 1990, Prof Malherbe left the public service to accept a post as Associate Professor at the Rand Afrikaans University, since 2003 renamed as the University of Johannesburg. In 1992 he was appointed Professor of Public Law. He has since been involved in under-graduate, post-graduate and extra-curricular courses in constitutional law, comparative human rights studies, education law, interpretation theory and legislative drafting. He has supervised several masters and doctorate students. He also lectures at other universities on the above topics and serves on the examining panels of various universities. He has served or is still serving on various committees of the University and the Faculty of Law, among others the Dean's Committee of the Faculty,

and he is the chair of the Students' Disciplinary Appeal Committee. He is also a member of the editorial committees of the *Journal for South African Law* published by the Faculty of Law, and *Discourse*, the prestige journal of the University. He undertook several study tours in Europe and the USA over the last decade, and lectured at various universities on constitutional and education law. During his overseas visits he served twice as visiting professor at the University of Salzburg, Austria, and at the Inter-University Centre for Education Law and Policy in Antwerp, Belgium. Since 2008, he visits Kenya regularly for the presentation of seminars to public servants and private lawyers on the topic of legislative drafting.

4. Conferences

Throughout his career, Prof Malherbe has attended and read papers at numerous international and national conferences, seminars and other occasions on diverse topics such as constitutional law, human rights and education law. Most often, these papers have been published in some form or another (see the attached list of publications). In 2005, Prof Malherbe was one of the organisers of a nationwide conference in Cape Town on legislative drafting.

5. Publications

Prof Malherbe is the co-author of various textbooks on constitutional law and of three popular publications on the South African Constitutions of 1993 and 1996. He is co-author of *Constitutional Law*, a text book on South African constitutional law already running into its fifth edition. He is the co-editor of four publications on education law, and contributed to several national and international textbooks on education law. He has published over a hundred articles on constitutional development and change, constitutional systems, intergovernmental relations, parliamentary procedures, and the protection of specific human rights, in particular religious (12 publications) and education (31 publications) rights, and the right to academic freedom (9 publications).

6. Involvement

Prof Malherbe was involved in different ways in the constitution making process of the nineties. In 1993, he served as an adviser on local government issues at the Kempton Park negotiations on the interim Constitution of 1993. During 1994 he drafted a new set of standing rules for the newly established Gauteng Provincial Legislature. He still advises the Provincial Legislature on constitutional and procedural matters, and has also advised the Legislature on language issues and during 1998 drafted a Language Policy Bill introduced in the Legislature. From 1995 to 1996 he was closely involved as an adviser in the constitution making process conducted by the Constitutional Assembly on the South African Constitution of 1996. He still advises governmental, educational and other bodies, including churches, on constitutional and other legal matters affecting them.

Apart from his interest and research in structural issues, such as parliamentary procedures and intergovernmental relations, Prof Malherbe is keenly interested in the protection of human rights and in education law. He is an executive member of the South African Education Law Association (SAELA), and the South African Inter-University Centre for Education Law and Policy (CELP). In these capacities, he is closely involved in the development of Education Law as a separate field of study in South Africa.

Currently, Prof Malherbe is a member of a small task team drafting a South African Charter of Religious Rights and Freedoms. During 2008 he also served on a task team that developed proposals for the future development of the provincial system in South Africa.
